In producing herewith one arrested accused person namely Moni Sarkar (M/22) S/O- Monoranjan Sarkar of Khudiram Colony, W/no.18 P.S- Siliguri, District - Darjeeling along with seized articles (1) 10 (Ten) sealed Bottles of Old Monk Deluxe Rum each bottle containing 750 ml. (2) 01 (One) Nylon Bag which was used for carrying the seized articles SL. N- 1.

I, ASI Nakul Ch. Singha of Panitanki TOP under Siliguri PS hereby lodge this written complaint against the above noted accused person to the effect that on 22.03.2026 at 23.05 hrs received secret source information that one person is carrying huge quantity of liquor through Sevoke Road and approaching towards Harijan Busty. Accordingly informed the same to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 599, dated 22.03.2026 and thereafter as per his direction I along with, ASI Surojit Mallick, C/1036 Gopal srivastav left from Panitanki TOP to work out the veracity of information. On arrival near Bazar Kolkata, Sevoke Road, Siliguri at 23.25 hrs being pointed out by the source, found that one person is proceeding with huge quantity of liquor carrying in a Nylon bag. Accordingly I have intercepted & apprehended him. Then I searched him in presence of two independent witnesses named (i) Prassidha Rai S/O- Lt. Mahesh Rai of Nagri, P.S- Sukhia Pokhri, Dist- Darjeeling A/P- Limbu Busty, Check Post, P.S- Bhaktinagar, Dist- Jalpaiguri & (ii) Ratan Mandal S/O- Sarimal Mandal of Jangipur, P.S- Gangarampur, Dist- Dakshin Dinajpur A/P- Ashigarh, P.S- Bhaktinagar, Dist- Jalpaiguri and recovered 10 (Ten) sealed Bottles of Old Monk Deluxe Rum each bottle containing 750 ml. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sell the same illegally to the local public of Bagrakote and adjacent areas for his wrongful gain and livelihood. Accordingly I seized the (i) 10 (Ten) sealed Bottles of Old Monk Deluxe Rum each bottle containing 750 ml. (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made in between 23.35 hrs and 23.45 hrs. Then I arrested the accused person u/s 35 (1) BNSS after explaining charges against him.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person Moni Sarkar (M/22) S/O- Monoranjan Sarkar of Khudiram Colony, W/no.18 P.S- Siliguri, District - Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
