Subject: Complaint regarding missing truck and theft / criminal breach of trust

Respected Sir,

I, Amit Bhansali, Son of Shri Nagraj Bhansali, Bhansali Enterprises, Bhansali Bhawan, Sevoke Road, Siliguri having my godown Opposite Bhaktinagar Thana, Siliguri, respectfully wish to lodge a complaint regarding a serious matter of theft and criminal breach of trust.

On 11/03/2026 we loaded the truck from transporter Rajasthan Assam Roadlink bearing registration number AS-01QC 8316, carrying approximately 30 MT of GC goods, departed from Bhaktinagar, Siliguri for Karimganj, Assam. However, the said vehicle has not reached its destination as of 17/03/2026.

The approximate value of the goods is ₹32,12,662/-.
The details of the driver and vehicle owner are enclosed herewith.

After searching through all our sources we found that the vehicle is at Chapar, Assam (near Bilasipara) in a petrol pump but there was no materials in that vehicle.

In light of the seriousness and urgency of the matter, we request you to kindly:


1. Register an FIR at the earliest.
2. Initiate an immediate and thorough investigation.
3. Take immediate steps to trace, seize, and recover the goods and identify and apprehend the persons involved.
4. Take strict legal action against all individuals responsible.
