Subject: Complaint against husband, in-laws, and others for domestic violence, physical assault, criminal intimidation, and illegal custody of child

Respected Madam,

I, Seema Sarkar, Wife of Sri Bidhan Barman and Daughter of Late Suresh Sarkar, presently residing at Deshbandhu Para, near Himachal Sangha Club, P.S. Siliguri, District Darjeeling, would like to inform you that I was married to Bidhan Barman on 14/05/2015 according to Hindu Rites and Customs. Prior to our marriage, we were in a relationship of love and, with the consent of both families, our marriage was solemnized. After the marriage, my husband, although a permanent resident of Haldibari, used to reside in Siliguri. Therefore, after about one month of marriage, I started living with him at my parental home, and we continued our marital life there for approximately 8 years. Out of our wedlock, a female child was born on 17/03/2016, namely Bidiya Barman.

I would like to further inform you that, at the time of said marriage, my mother provided various household articles including a steel bed, three-door steel almirah, sewing machine, refrigerator, utensils, electronic items, and gold ornaments (nose ring, nose pin, nath, finger rings, earrings, and gold chain).

I would like to further inform you that, after marriage, my husband started a motor repairing garage near Matri Radio at Deshbandhu Para. Since the beginning of my marriage, my mother-in-law Sushma Barman and father-in-law Bimal Chandra Barman used to mentally and physically torture upon me. They would insult me regarding the articles given at the time of marriage and even physically assaulted me repeatedly. After about one year of marriage, my husband became addicted to alcohol and used to return home in an intoxicated condition almost every night and brutally assault me. My parents tried several times to resolve the matter, but my husband never respected them. Being compelled by the situation, in December 2024, my mother arranged a piece of land at Baribhasa under New Jalpaiguri Police Station and constructed a house there at her own expense. Thereafter, I started living there along with my husband and minor daughter, carrying all my belongings and documents.

I would like to further inform you that, after some time, my husband's parents also started living with us in that house, and thereafter the torture resumed. My husband,

instigated by his parents, again started physically assaulting me under the influence of alcohol.

I would like to further inform you that, On 28/11/2025, at around 2:00 AM, my husband along with his parents brutally assaulted me and forcibly drove me out from the house which my mother bought for me. Somehow, I informed my mother, who came and took me at my mother's place. Due to the severe physical and mental trauma, I was unable to communicate properly for a long period. Since then, my husband has never made any attempt to contact me or inquire about my condition.

I would like to further inform you that, after recovering slightly, on 16/03/2026, I went to my matrimonial home, but my husband did not allow me to enter into my house. When I tried to enter, he assaulted me and drove me from there. I repeatedly requested to them to meet with my daughter, but he refused. Later, I came to know that my husband had kept my daughter at the house of one Mamoni Das who is the distant relationship of my husband. Upon reaching there, Mamoni Das (wife of Samir Das), ^{Samir Das} alongwith Misthu Das (sister of Samir Das), Sambhu Das (brother of Mamoni Das), Riya Das (wife of Sambhu Das), Ankita Das (daughter of Samir Das), all are residents of Deshbandhu Para near Chocolate Factory, P.S. Siliguri, District Darjeeling, collectively assaulted me brutally and drove me from there.

I would like to further inform you that, furthermore, my husband is maintaining multiple illicit relationships and has completely abandoned me. He has also threatened me that if I try to interfere in his life, he will kill me and will make it as suicide.

Therefore, I humbly request you to kindly take necessary legal action against my husband, his parents, and the above-mentioned persons for their unlawful acts, including physical assault, cruelty, criminal intimidation, and illegal custody of my minor daughter.
