In producing herewith one arrested accused person namely Sukumar Barman (M/48yrs) S/O Lt. Ishwar Barman of 2no Takimari, Gajoldoba OP, PS- Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. TUBORG (Premium) Strong Beer, total 15 bottle, each bottle containing of 650 ML. Value (Rs=160.00 each X 15) = total value Rs. 2400/- (total quantity= 9750ML) Marked as "Exhibit-A" out of which 01(One) bottle taken as sample marked as "Exhibit-A-1"
2. Country sprite 60 UP Style as PET GALAXY BOSS containing of 250 ML each, total 08 Bottle, value (Rs. 80/- X 08), Total value Rs. 640/-.(total quantity=2000 ML) Marked as "Exhibit-B" out of which 01(One) bottle taken as sample marked as 'Exhibit-B-1'.

[Total Quantity – 11750 ML and Total Price – Rs. 3040/-]

I, SI. Ramanath Karjee of Gajoldoba Out Post under Bhorer Alo PS/SPC lodged a written complainant against the above noted person to the effect that today on 22.03.2026 during mobile van duty vide Gajoldoba OP GDE No. 643, Dated: 22.03.2026, at 18:55 hrs received a source information that one person Namely Sukumar Barman (M/48yrs) S/O Lt. Ishwar Barman of 2no Takimari, Gajoldoba OP, PS- Bhorer Alo, Dist. Jalpaiguri. Coming towards Gajoldoba Hanging bridge from gate bazar side with huge number of illegal country sprit and others alcohol for selling the same to the customer for his wrongful gain. Accordingly I informed to O/C Gajoldoba Out Post about the information. As per his kind instruction I along with mobile van force and ASI. Pranab Das and (1) C/1528 Sankar Roy all of Gajoldoba Out Post, Under Bhorer Alo PS/SPC proceeds to near Hanging bridge under Gajoldoba OP to work out the information. At 19.15 hrs we reached at the spot and at 19.20hrs found one person get down from one Public TOTO with one white colour bag containing of above mention liquor. we cordoned the said person being identified by the source. I detained the said person who disclosed his identity as noted above and recovered the above noted liquors from his possession. On interrogation he admitted his guilt and disclosed before police that he is permanent seller of liquor at 2no Takimari area. On demand he is unable to produce any valid documents of said seized liquor. Accordingly I seized the above noted liquor from the possession of above noted accused person Sukumar Barman after preparing proper seizure list. I took signature of the accused person in presence of witnesses. The seizure was made between 19.26 hrs to 19:42 hrs. Then I arrested the said person and issued Memo of arrest, Ground of arrest in presence of witnesses and informed his family member. All seizure was made under proper video graphy.

I therefore request you that a specific case may kindly be started against the accused person namely Sukumar Barman (M/48yrs) S/O Lt. Ishwar Barman of 2no Takimari, Gajoldoba OP, PS- Bhorer Alo, Dist. Jalpaiguri. under proper section of law.
