Respected Sir,

With due respect, in producing herewith 01 (one) arrested accused person named Gopal Barman (M/58 years) S/o-Lt. Baidyanath Barman of vill-Gokulvita, PO-Kamarvita, PS-Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. 01 (one) Nylon carry bag containing 10 (Ten) bottles of 70 UP India made liquor "KACHI", each bottle containing 300 ML, Total  $10 \times 300 = 3000$  ML/ 3 L), marked as "Exhibit-A", price of each bottle Rs. 40-/(Total Price  $40 \times 10 =$ Rs. 400-/)

I beg to report that I, ASI Utpal Das, S/O-Lt. Mahadeb Das of Bhorer Alo Police Station, Siliguri Police Commissionerate lodged this written complainant against one Gopal Barman (M/58 years) S/o-Lt. Baidyanath Barman to the effect that today i.e. on 23/03/26 at about 09.45 hrs, I along with force while performing PC mobile van duty (This refers to Bhorer Alo PS GDE No. 1033, Dated. 23/03/26) received a source information that one person was selling liquor in an open place at Ambari road, near Ambari Bazar under Bhorer Alo PS/SPC without any documents/license for his wrongful gain. As per kind instruction of my superior, myself along with SI Chiranjit Saha, C/322 Jayanta Roy proceeded towards Ambari road near Ambari Bazar under Bhorer Alo PS/SPC to work out the veracity of source information. After we reached at the spot and on being identified by the source our police party held raid at Ambari road, near Ambari Bazar under Bhorer Alo PS/SPC and recovered the above noted articles from his possession. During local enquiry it came to learn that he was selling the same from 01 (one) month in open market for his wrongful gain without any valid documents/license. In presence of available witnesses, I seized the above noted articles from his possession after preparing proper seizure list. The process of seizure was done in between 12.05 hrs to 12.15 hrs and the whole process of seizure is video-graphed. I then arrested him after maintaining all formalities. The ground of his arrest has been duly communicated with him in written.

Under the above circumstances, I would like to state that a specific case may kindly be started against the accused person namely Gopal Barman (M/58 years) S/o-Lt. Baidyanath Barman of vill-Gokulvita, PO-Kamarvita, PS-Bhorer Alo, Dist. Jalpaiguri under proper section of law and also to arrange for its investigation.
