Respected Sir,

With due respect, in producing herewith 01 (one) arrested accused person named Ananda Barman (M/26 years) S/o-Manindra Barman of vill-Farabari, Velkipara PO-Sahudangi Hat, PS-Bhorer Alo, Dist. Jalpaiguri along with the following seized articles as per proper seizure list:

1. 10 (Ten) bottles of "HIMALAYAN GOLD 60 UP" country spirit (each bottle contains 600 ML), Total quantity-6000ML/6 L, (price of each bottle is Rs. 170-/, Total value 10*170= Rs.1700-/) which was kept in a nylon made bag
2. 01(one) nylon made bag.

I beg to report that I, ASI Inzamamul Hoque, S/o-Lt. Shoyeb Ahashan of Bhorer Alo Police Station, Siliguri Police Commissionerate lodged this written complainant against one Ananda Barman (M/26 years) S/o-Manindra Barman to the effect that today i.e. on 23/03/26 at about 11.05 hrs, I along with force while performing K-39 (I) mobile van duty received a source information that one person was selling liquor in an open place at Ambari road under Bhorer Alo PS/SPC without any documents/license for his wrongful gain. As per kind instruction of my superior, myself along with C/505 Tapash Dutta and NVF/82 Paban Biswas proceeded towards Ambari road under Bhorer Alo PS/SPC to work out the veracity of source information. After we reached at the spot and on being identified by the source our police party held raid at Ambari road under Bhorer Alo PS/SPC and recovered the above noted articles from his possession. During local enquiry it came to learn that he was selling the same from 02 (two) months in open market for his wrongful gain without any valid documents/license. In presence of available witnesses, I seized the above noted articles from his possession after preparing proper seizure list. The process of seizure was done in between 12.15 hrs to 12.30 hrs and the whole process of seizure is video-graphed. I then arrested him after maintaining all formalities. The ground of his arrest has been duly communicated with him in written.

Under the above circumstances, I would like to state that a specific case may kindly be started against the accused person namely Ananda Barman (M/26 years) S/o-Manindra Barman of vill-Farabari, Velkipara PO-Sahudangi Hat, PS-Bhorer Alo, Dist. Jalpaiguri under proper section of law and also to arrange for its investigation.
