With due respect I am producing herewith one (01) arrested accused person namely Shib Choudhury @ Munga (22 yrs./M) So- Subal Choudhury of Hemanta Basu Colony, Maharaj Colony, PS- Siliguri, Dist- Darjeeling under proper arrest memo along with following seized articles -

- v) One (01) Black Sunshot Ranger Bicycle made by Hero Company
- vi) One (01) Black and blue stripe Electrican Ranger Bicycle made by Hero Company
- vii) One (01) Black and Blue Next Ranger Bicycle made by Hero Company
- viii) One (01) Black and Green Strip Ranger Bicycle made by Hercules

I ASI Nilam Swarnakar presently attached with NJP PS, Siliguri Police Commissionerate under your kind control beg to state that today on 20/03/2026 I received a secret source information that one person namely Shib Choudhury @ Munga have seen with numbers of bicycle at abandoned Railway Quarter, Suryasen Colony, Block E, Near Loknath Mandir under NJP PS in suspicious way. Accordingly I informed the matter to you and noted in GDE vide N.J.P PS GDE No 968 Dated 20/03/2026. As per the kind direction and instruction I along with ASI Khagen Barman, C/453 Uttam Dey, C/1462 Sajan Tamang, VP 13 Jamirul Islam, VP/08 Laxman Roy left for abandoned Railway Quarter, Suryasen Colony, Block E, Near Loknath Mandir under NJP PS for verify the matter. After reaching in the spot I found the above noted person was standing in suspicious way. After seeing the police party the above noted person flees away from the spot but after a hot chase somehow we managed to detain him. On being asked the apprehended person disclosed his name and address mentioned above and admitted that he have 08 Nos of stolen bicycle and concealed them at one abandoned Railway Quarter. Accordingly as per the leads I along with force and the above noted detained person namely Shib Choudhury @ Munga had been to abandoned Railway Quarter, Suryasen Colony, Block E, Near Loknath Mandir under NJP PS as identified by him and we recovered above noted Eight (08) No's of bicycles in different colors, different types and different brands as mentioned above. On being asked, he failed to produce any papers in support of the above bicycles and I seized the same under proper seizure list and arrested hi under proper memo of arrest and ground of arrest is duly communicated with him. The whole process of seizure and arrest was made in between 20.15 hrs to 20.35 hrs on 20.03.2026. It is crystal clear and reason to believe that the above noted accused person having the nos of bicycle by illegal means or by stolen means for dishonestly dispose the same to earn huge money illegally.

Hence, I pray to you considering the offence the specific case may kindly be started against the arrested accused person namely Shib Choudhury @ Munga (22 yrs./M) So- Subal Choudhury of Hemanta Basu Colony, Maharaj Colony, PS- Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigation.
