Subject: - F.I.R.

Sir,

With due respect, I am producing herewith one (01) accused person namely Rajen Lohar (20 yrs) S/O Lt. Man Bahadur Lohar of Siyok Gudamdura, PS Sukhia Pokhri, Dist Darjeeling under arrest under arrest and the following articles under proper seizure list viz (i) 01 (one) red colour bag containing 24 bottles of "HAYWARDS" 5000 Premium Strong Beer each bottle containing 500 ml i.e, total (24 x 500 ml = 12 ltrs) - Marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1" and (ii) 01 (one) paper made cartoon containing 32 numbers of paper made pouch of "Officer Choice" ELITE WHISKY each pouch containing 180 ml ie, total (32 x 180 ml = 5.760 ltrs)- Marked as Exhibit "B" out of which one pouch of the same taken as sample for examination and marked as Exhibit "B1". I ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the above mentioned arrested accused person namely Rajen Lohar (20 yrs) S/O Lt. Man Bahadur Lohar of Siyok Gudamdura, PS Sukhia Pokhri, Dist Darjeeling to the effect that on 22.03.2026 at about 22:05 hrs, I received specific secret information that one person carrying and possessing a huge quantity of illicit liquor was standing at Namchi Taxi Stand, Siliguri Junction under P.S. Pradhan Nagar, Dist. Darjeeling with a view to deliver the same to his design customers for wrongful gain. Accordingly, I diarized the information in PS General Diary vide Pradhan Nagar PS GDE No. 1384 dated 22.03.2026, and the matter was intimated to you. As per your kind order and direction, I along ASI Bikash Roy, C/1119 Tanmoy Roy and other force personnel proceeded to the spot by Government vehicle with investigation kit to verify the veracity of the information. Under this circumstance any search warrant or authorization for search cannot be obtained for want of time. So we had to move fast without affording the miscreant, the opportunity for the concealment of evidence or facility for his escape. On the way to Siliguri Junction, I informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS-Siliguri, Dist. Darjeeling over Mobile Phone and requested him to come to Siliguri Junction with his camera for the purpose of videography if required and also informed night RT van Officer SI Biplab Barman and requested him to come to Siliguri Junction to accompany with us.

At about 22:20 hours, we reached at near SNT, Siliguri Junction and requested two independent witnesses namely (i) Raja Sahani (26 yrs), S/O Chunchun Sahani of Rajendra Nagar, Coolipara, Ward No. 01, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 9382167087) and (ii) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling (M. No 9339932433) and shared the information with them and requested them to remain present at the spot and act as independent witness if any search and seizure would be made upon which they agreed and expressed their willingness to co operate with me as well as to act witness. Then I contacted with my source and being pointed by the source, I noticed that one person was standing with one red colour bag and one paper made cartoon in his possession at Namchi Taxi Stand, Siliguri Junction. Accordingly, I detained the said person with one red colour bag and one paper made carton in his possession. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, he disclosed his identity as noted above. On search the red colour bag and the paper made carton under his possession recovered the above mentioned articles from his possession. On demand he failed to produce any valid documents for possessing such liquor. Accordingly, I seized the above mentioned articles under proper seizure list in presence of independent witnesses noted above. The entire process of search, seizure, and labelling was made under the coverage of videography between 22:45 hours and 23:25 hours at the spot. During interrogation, the accused person admitted his guilt and disclosed that he is running such business of liquor without any license since few months for his wrongful gain. Accordingly, I arrested him under proper memo of arrest and observing all the legal formalities and inform him regarding ground of his arrest in written and issued copy of Memo of arrest and ground of arrest to him.
