Subject : F.I.R

Respected Sir,

With due respect I Santosh Sharma, Son of Late Ram Dayal Sharma, Resident of Sarkar Para, Bankim Nagar, Ward No. 41, Siliguri. A Social Worker and Teacher by profession.

That I am providing free coaching to the students from my neighbors and surrounding since from 2022, so in respect of this matters I would like to lodge an FIR against Mr. Bikash Thapa Son of Mr. Rajesh Thapa resident of Devidanga, Siliguri but temporary residing at Shastri Nagar, Siliguri from past few years.

That on 22<sup>nd</sup> March 2026 Sunday at around 2:48 PM just few minutes after when I called up his wife Mrs Asna Thapa as requesting her for repayment of my wife's money i.e, sum of Rs. 3,500/- which his husband has fraudulently taken from Mr. Sapan Haldar who is a water supplier. Actually Mr Haldar has Rs.6,500/- to pay us for (20 Liters Jars) bottles of water as he collected to distribute (audio record of our conversation between me and Mr. Haldar claiming that sum of Rs. 3,500/- in three installment has been forcefully taken by Bikash Thapa and he gulped it up without any information to us such act has been recorded and it is with me. As I mentioned above said Bikash Thapa called me just after a conversation with his wife and ask me to come near Shivmandir near to our house. without any quantum of doubt I reached and ask him what is the matters? Then he just stepped down from his scooty and started assaulting me physically and abused me verbally and also passed various communal discriminating sentences he was so wild as he was not listening my words he assaulted me physically without any mersey even after begging him to leave me I also requested him to talk with me and stop hitting me but he didn't listen to me even I requested him that you can pay in easy installment of Rs. 1000/- per month but he didn't reacted. He knew that I am a patient of diabetics, high blood pressure and peptic Ulcar still he kicked me

forcefully in my abdomen and my back and must worst things is that he hold my "sikha" and dragged me from Shivmandir to Alok Mandal house he even tried to insert some sharp object in my neck as I was almost senseless with his sudden violent attack I could not properly recognized the weapon. Then when my wife came out and ask him why you are doing so then he verbally abused her in front of many peoples and threaten us that if you register an F.I.R then he will kill us as soon he released from jail. Such threatening has been recorded in CCTV of Alok Mandal and Rana's Premises as he assaulted me near Shivmandir such unlawful action has also been recorded in CCTV of nearby houses. Further his statements and actions are very unlawful has he is a habituate criminal since past.

Considering his illegal and inhuman act in respect my incident he boast and claimed or such heinous action as his father is a senior lawyer he himself is a B.J.P Shakti Kendra Pramukh and has dealt with many such kind of cases and can easily handle and nullified with his powerful influence.

That I have enclosed medical report from Civil Hospital for further reference and if anything happens in the due course of legal proceeding to me and my family unnaturally or sudden he will be sole responsible for that.

I, therefore, kindly request your good authority to take immediate action against the above named accused person for the ends of justice.
