SUB: COMPLAINT AGAINST SANDIP GUPTA FOR CIRCULATING PROVOCATIVE VIDEO
INCITING COMMUNAL VIOLENCE AND DEFAMING ME AND MY BROTHER.

Sir,

I, Sri Rabindra Singh son of Sri Samser Singh resident of Samser Villa, Shastri Nagar, Ward No. 41 of Siliguri Municipal Corporation, Siliguri, Police Station- Bhaktinagar, District- Jalpaiguri, would like to draw your kind attention to the fact that one of the main cause of my daughter namely Charanjeet Kaur death was Sri Sandip Gupta son of Manoj Kumar Gupta resident of Durga Nagar, Ward no. 40 of Siliguri Municipal Corporation, Siliguri, Police Station- Bhaktinagar who assured to provide Air Ambulance Service for my daughter and on that behalf took money from me and failed to provide Air Ambulance Service to me for my daughter (now deceased) and to that effect I have lodged a complaint against him before the Bhaktinagar Police Station being case no. 27 of 2026 dated 12.01.2026.

Sir, as I was mentally not stable due to demise of my minor daughter, I have lodged my complaint against the said Sri Sandip Gupta before the Bhaktinagar Police Station on 12.01.2026 and to my surprise the said Sri Sandip Gupta's father namely Sri Manoj Kumar Gupta have lodged a false written complaint being Bhaktinagar Police Station Case No. 10 of 2026 dated 05.01.2026 i.e prior to my complaint against my brother Sri Manjit Singh on 05.01.2026 stating that my brother along with 10/15 unknown person on 04.01.2026 threatened to kill his son i.e Sri Sandip Gupta.

Sir, now I have come across a video in Facebook of Sri Sandip Gupta (<https://www.facebook.com/share/17wnf27KW4/?mibextid=wwXlfr>) stating that there has been attempt to kill Sri Sandip Gupta and his family thrice from 04.01.2026 where he stated that on 04.01.2026 30/35 person came to his home with stone and Sword and threatened to kill him and further stated that all person from UP/BIHAR along with their family lineage will be killed.

Sir, I belong to Sikh community who believe in humanity service irrespective of religion and further we Sikh are minority in whole of West Bengal having minor/negligible share in Siliguri and Surrounding population.

Sir, the said Sri Sandip Gupta have used this provocative language to only instigate communal tension and defame me and my brother image in the society and further gain sympathy from his community people and other people by playing victim card whereas he is the main culprit and one of the major reasons for the death of my minor daughter.

So, I request you to kindly take necessary action against the said Sri Sandip Gupta for Circulating provocative video and defaming me and my brother.
