Sir,

In producing herewith one arrested lady accused person namely Sohela (28 years, w/o. Md. Khursid of Vill. Biswas colony, PO+PS. Matigara, Dist Darjeeling (not verified) along with the following seized articles under seizure as per seizure list:

- (i) One transparent zip-lock plastic packet containing with said to be Brown Sugar weighing 284 grams.
- (ii) One Realme mobile phone having SIM no. 9933434500, IMEI no. 863352074872095.
- (iii) One Vivo mobile phone having SIM no. 9749160821, IMEI no. 865407072306153.
- (iv) 33 Pcs. Of Rs. 500/-, Total amount  $500 \times 33 = 16,500/-$
- (v) 17 Pcs of Rs. 200/-, Total amount  $200 \times 17 = 3,400/-$
- (vi) 54 Pcs of Rs. 100 /-, Total amount  $100 \times 54 = 5,400/-$

I, SI Mrinal Basunia, s/o. Sri Manmatha Basunia of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned lady accused person to the effect that on 23.03.26 at about 15.30 hrs, received a reliable source input that one lady person of Biswas Colony is selling huge quantity of suspected to be Brown Sugar Narcotics drugs clandestinely to deliver the same to her design customers from her house at Biswas colony under Matigara PS, SPC. The matter was diarized in Matigara PS vide Matigara PS GDE No. 2308, dated 23.03.26 and subsequently, I informed the matter in written to the I/C Matigara PS, SPC and being directed, myself along with ASI Dipak Chhetri, ASI Bikash Roy, ASI Chandra Prakash Adhikari Const/868 Sujal Roy, C/523 Sanjit Kundu, LC/1286 Anisha Chhetri, all are Matigara PS with investigation kit left for Biswas colony under PS Matigara by govt. vehicle to verify the veracity of the information and waiting there vide Matigara PS GDE no. 2309 dated. 23.03.26 and M.C.C No- 804/26, Dated 23.03.26.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Biswas colony and meanwhile called two independent witnesses namely (1) Md. Jahar Ali, S/O. Lt. Md. Karimuddin (Ph-9382263498) and (2) Md. Pajir, s/o. Lt. Md. Karimuddin both of Matigara bazar, PO+PS. Matigara, Dist Darjeeling and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure.

Being accompanied by source and the witnesses, on being pointed by source at about 16.25 hrs we found one lady person standing in her respective house of Biswas

colony. On seeing the Police party the suspect lady person try to escape from the house. But we detained the said lady person in her house and we disclosed our identity and the information in hand and stated her that she will be searched in person for the purpose. At this, she disclosing her name and address as noted above. She is admitted that she has illegally possessed brown sugar in her possession for selling the same to her designed customers as per requirement for her wrongful gain.

I then gave her written notice to be searched in presence of Spl. Executive Magistrate. Then she agreed to be searched in presence of Spl Executive magistrate. Accordingly, I informed the matter to Sri Manojit Sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, regarding the interception of the lady accused person suspected to be possessed Brown Sugar and requested him to come at Biswas colony, Matigara to remain present and to supervise the search and seizure as soon as possible.

Accordingly at 16.55 hrs Sri Manojit sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC arrived at the spot as a Spl Executive Magistrate as he was present in Biswas colony and subsequently, under his supervision in presence of witnesses the process of search of the detained lady person for conducted following all formalities keeping her decency and recovered the above noted article from the exclusive possession of above noted accused lady person. Subsequently, being demanded in presence of Sri Manojit sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC the detained lady person failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found (i) One transparent zip-lock plastic packet containing with said to be Brown Sugar weighing 284 grams, (ii) One Realme mobile phone having SIM no. 9933434500, IMEI no. 863352074872095, (iii) One Vivo mobile phone having SIM no. 9749160821, IMEI no. 865407072306153, (iv) 33 Pcs. Of Rs. 500/-, Total amount  $500 \times 33 = 16,500/-$ , (v) 17 Pcs of Rs. 200/-, Total amount  $200 \times 17 = 3,400/-$ , (vi) 54 Pcs of Rs. 100 /-, Total amount  $100 \times 54 = 5,400/-$  of above noted lady accused person. Then, I seized the above noted article at the spot under proper seizure list duly signed by the independent witnesses as shown by the lady accused person. I also labeled and sealed all the articles in presence of Sri Manojit Sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC and witnesses and lady accused person. The whole process of seizure was made in between 17.05 hrs to 17.30 hrs.

Being further asked, the apprehend lady person admitted in presence of Sri Manojit Sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC, and other witnesses that she procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to her designed customer for her personal gain by illegal means. She also disclosed that she has been dealing in such business of procuring and selling of brown sugar illegally for last few months under.

Then, I arrested the above noted lady accused person namely Sohela Khatun (28 years, w/o. Md. Khursid of Vill. Biswas colony, PO+PS. Matigara, Dist Darjeeling after observing all formalities and informing the ground of her arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the arrested lady accused person is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Somnath Chatterjee (Ph. No. 9064648755), S/O. Sushil Chatterjee of Vill. Arabinda pally, Gokhel road, W. no. 22, PO. Rabindra nagar, PS. Siliguri, Dist. Darjeeling.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the lady accused person namely Sohela Khatun (28 years, w/o. Md. Khursid of Vill. Biswas colony, PO+PS. Matigara, Dist Darjeeling and arrange for its investigation.
