
SUB: Complaint to lodge FIR Against (1) Sri -Akash Goyal S/o. Ajay Goyal resident of Swastika Apartment 2nd Mile Sevoke Road, Ward No.41 of SMC, P.O -Sevoke Road P S Bhakti Nahar (2) Sri Shekhar Singh S/O. Mahipal Singh, resident of Gurung Basti P.O. & P.S. Pradhan Nagar Dist- Darjeeling (3) Sri Rana Das S/S. Not Known resident of Bengal cabin Swamiji More P.O. & P.S. Siliguri , Dist- Darjeeling.

Dear Sir,

I undersigned beg to state as follows:

1. That I am the sole owner of a BMW 2 SERIES GRAN COUPE, a 4(four) wheeler vehicle, Being No.WB84F9968, Engine No. 0032Y381, Chassis No. WB37AK05NY408141.
2. That I have purchased the said 4(FOUR) Wheeler Vehicle by taking loan from Axis Bank, Chanchal Branch, Malda, being Loan Account No. AUR003507311637 & UCR003509550390.
3. That I was interested to sell my above mentioned vehicle to third Person persons and the above named accused person namely Sekhar Singh, son of Mahipal Singh, a resident of Gurung Busti, P.O. & P.S. Pradhan Nagar, District Darjeeling, who introduced himself an employee of ICICI Bank and the accused person namely Rana Das, a resident of Swamiji More, Siliguri, is also known to be an employee of Bandhan Bank they are assured me that they will sell the vehicle and closed the Loan from Axis Bank , Malda and rest amount will hand over to me.
4. That subsequently I came to know the ownership of the said vehicle was transferred illegally carried out by Sekhar Singh through Kalimpong RTO, using fake documents bearing my signature without my knowledge, consent, or lawful authorization and without the closing the Loan from my bankers Axis Bank Ltd, Chanchal and with out NOC from Bankers.
5. That upon inquiry through internal sources, I discovered that on 01.04.2025, the name on the Registration Certificate (RC) or Bluebook was changed to the accused person Akash Goyal, and such transfer was made by the Kalimpong RTO where as my vehicle is registered with RTO , Malda.

Received on 23/03/2026 at 22.15 Hrs vide mtu P.S GDE No-2326, Over this started mtu P.S Case No - 166/26, dt - 23/03/2026, v/s - 336(3)/340(2)/318(4) of BHS. ASST Pema Darjee Sherepa. Will investigate the case.

6. That thereafter, I have sent a legal notice dated 12-06-2025 to the accused persons No 1 & 2 through my Ld. Advocate Sri Joydev Chakraborty, through Registered Post bearing No. EW32398437IIN, addressed to their residential address and same has been received by the accused persons on 16.06.2025.
7. That the aforementioned collusive, unauthorized, and fraudulent actions of the accused persons with the help of RTO , Kalimpong clearly reflect mala fide intent and constitute serious criminal misconduct, including defalcation and misappropriation of property, thereby amounting to criminal breach of trust and cheating under the relevant provisions of law.
8. That today on 25.02.2026 at about 3:30 P.M. one Police Personal from Bhakti Nagar PS with the help of Matigara Police they visited at my house where the said vehicle was parked and the police personal has taken the said vehicle to the Bhaktinagar Police Station without any seizure list and any documents .
9. That being a law abiding citizen I therefore request you sir kindly look in to the matter as serious basic and hand over my vehicle for the ends of Justice and take necessary illegal action those who are involve for creating a forged and fabricated documents if the RTO, Kalimpong also involved please take necessary step .

In view of the facts stated above, I most respectfully request your good office to kindly register an FIR, conduct a fair and thorough investigation, identify all persons involved including the concerned RTO officials, take appropriate legal action in accordance with law. I further request that necessary steps be taken to restore my lawful ownership of the vehicle.
