**Subject: Complaint regarding cruelty, dowry demand, criminal intimidation, and false allegations by husband and mother-in-law**

Respected Sir/Madam,

I, Suchismita Sadhukhan Das, wife of Krishna Kamal Das, resident of Ratan Lal Brahmin Sarani, Village-Thiknikata, GP Matigara Dist Darjeeling P.O Sushruta Nagar, P.S Matigara West Bengal PIN-734012 would like to file a complaint against my husband namely Kamal Das Son of Swapan Das and Ruma Das, Resident of S Kazi Sabyasachi Lane, Hatimore, Subhash Pally, Dist Darjeeling P.O and P.S Siliguri West Bengal PIN-734001 and mother in law namely Ruma Das, wife of Swapan Das, Resident of S Kazi Sabyasachi Lane, Hatimore, Subhash Pally, Dist Darjeeling P.O and P.S Siliguri West Bengal PIN-734001 on following grounds:

1. That I was legally married to my husband Krishna Kamal Das Son of Swapan Das and Ruma Das, Resident of S Kazi Sabyasachi Lane, Hatimore, Subhash Pally, Dist Darjeeling P.O and P.S Siliguri West Bengal PIN-734001 on 12th June 2025 as per Hindu rites and customs.
2. That after marriage, my husband and I went to Oman in 1<sup>st</sup> August 2025 for his work.
3. That during my stay in Oman, my husband subjected me to grave mental cruelty and immoral conduct, inasmuch as he confined me in a room and left me in the company of a male colleague, and pressured me to stay with him in an inappropriate and objectionable manner, which was against my will and dignity.
4. That my husband also threatened and instructed me not to disclose this incident to anyone, thereby causing severe mental trauma and fear.
5. That on 5th August 2025, we returned to India due to the unfortunate demise of his father.
6. That after performing the last rites, my husband again left for Oman, leaving me behind at my matrimonial home.
7. That thereafter, my mother-in-law started subjecting me to mental cruelty, falsely accusing me of being a thief and alleging that I had stolen household items.

8. That she also falsely accused me of spreading rumours about her in the neighbourhood, thereby defaming me and causing mental harassment.

9. That my husband, instead of protecting me, started threatening me with dire consequences over phone calls.

10. That on November 2026, both my husband (via calls) and mother-in-law forced me to leave the matrimonial home, thereby abandoning me.

11. That my mother-in-law further stated that I would only be allowed to return to my matrimonial home with the permission of my husband, thereby unlawfully restricting my right as a legally wedded wife.

12. That both my husband and my mother in law demanded dowry from me and subjected me to continuous harassment and torture for the same.

13. That on 19th January, they lodged a false case against me vide case no. N.G.R 192(II) 26 with malicious intent to harass and pressurize me.

14. That due to continuous threats and intimidation by my husband and mother-in-law, I remained silent and could not approach the authorities earlier.

15. That I made several attempts to resolve the matter amicably, but my husband refused to cooperate or sit for any settlement discussion.

16. That due to their continuous acts, I have suffered immense mental trauma, harassment, and emotional distress.

In view of the above facts, I humbly request you to:

- Register an FIR against my husband and mother-in-law under appropriate sections of law,
- Take immediate legal action against the accused persons.
- Provide me protection from further harassment and threats.
