Respected Sir,

I, **Vivek Saha**, Son of Ratan Saha, resident of Vivekanandapally, Kadamtala, P.S. Matigara, District - Darjeeling, Pin - 734011, State - West Bengal, Mobile No. 9883265967, most respectfully submit this complaint for your kind consideration.

That I had a friendship with a girl namely Supriya Ghosh, who belongs to Gauripur Gram Panchayat, Dharampur, Malda. I also have an ancestral house at Malda. For the past few days, we were talking to each other cordially as friends and there was no dispute or misunderstanding between us. I have no complaint whatsoever against Supriya Ghosh.

However, at the end of February, 2026, I received a phone call from one person namely **Sisir Ghosh**, whose phone and WhatsApp number is 9883105502. I had no prior knowledge about him and came to know his name through the Truecaller application. During the phone call, he used highly abusive and slang language towards me and my family members. He further threatened me with dire consequences and stated that if I visit my ancestral house at Malda, he would kill me. Not only this, he also threatened that he would come to my residence at Vivekanandapally, Kadamtala, P.S. Matigara, and kill me. A few days thereafter, while I was present near the Shiv Mandir area, adjacent to Narsingha Vidyapith School, within the jurisdiction of Matigara Police Station, one unknown person suddenly approached me and, without any provocation, assaulted me by slapping me. When I confronted him and enquired about his identity, he disclosed his name as Sisir Ghosh and immediately fled away from the spot. He has also sent threatening and abusive messages to me over WhatsApp from the above-mentioned number. I have preserved the WhatsApp chat records as evidence of such threats and abusive language.

Due to such continuous threats and intimidation, I am in deep fear for my life and safety, as well as for the safety of my family members. I apprehend that the said Sisir Ghosh may cause serious harm to me at any time.

Therefore, I most humbly request you to kindly treat this complain as an FIR and initiate appropriate legal action against the said Sisir Ghosh under relevant provisions of law. I also request you to provide necessary protection to ensure my safety.

I shall remain ever grateful for your prompt action in this matter.
