In producing herewith one arrested lady accused person namely Rina Mahato W/O Ashok Mahato of Santoshinagar, Machhli More, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles viz.

(1) Total 41 (Fourty-one) bottles of "Himalayan Gold 60 UP country spirit" each bottle containing 600 ml. Total 24.6 Ltrs.

I, SI. Kalachand Mandal of Khalpara TOP under Siliguri PS, hereby lodge this written complaint against the above noted accused person to the effect that on 25.03.2026 at 15.45 hrs received secret source information that one person was selling huge quantity of country liquor bottles illegally without any documents/license at Machhli More, Santoshinagar, Khalpara, Siliguri. Accordingly informed the same to O.C Khalpara TOP and being directed, myself along with force including lady Constable (LC- 1216 Pushpanjali Yonzong) left towards Machhli more, Santoshinagar under Siliguri PS to work out the veracity of the information. This refers Khalpara TOP GDE No. 742, dated 25.03.2026.

On arrival near Machhli More, Santoshinagar, Khalpara, Siliguri at about 16.15 hrs, being pointed out by the source, found one lady person was selling illicit liquor to her customer at her shop situated at Machhli More, Santoshinagar under Siliguri Police Station. Accordingly we apprehended her maintain all formalities, keeping her decency and recovered total 41 (Fourty-one) bottles of "Himalayan Gold 60 UP country spirit" each bottle containing 600 ml. Total 24.6 Ltrs . At the time of conducting raid, the local customers who were taking liquors are able to fled away from the spot.


During interrogation the accused failed to produce any documents/license in support of the same and stated that she was selling the same illegally to the local public of Santoshinagar area for her wrongful gain and livelihood. Accordingly I seized total 41 (Fourty-one) bottles of "Himalayan Gold 60 UP country spirit" each bottle containing 600 ml. Total 24.6 Ltrs under proper seizure list in presence of witnesses and duly sign by them and accused person. The seizure was made in between 16.45 hrs to 17.15 hrs. under videography. I then arrested the lady accused person u/s 35(1) of BNSS after explaining charges against her and communicating ground of arrest.

Hence, under the above noted circumstances, I am submitting this written complaint against the above lady accused person Rina Mahato W/O Ashok Mahato of Santoshinagar, Machhli More, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling for starting a specific case under relevant section of Law and arrange for its investigation.
