Sir,

I, Amit Malakar, son of Nibaran Malakar, resident of East Ghogomali, easternbypass bot tola, P.O. Ghogomali, P.S. Bhaktinagar, Dist. Jalapaiguri, drawing your keen attention on the following facts-

That, on 22-03-2026 between 8.30 to 9.20 a.m some unknown hooligans broke down the aladbaster tin-shade structure of my chamber and tried to enter with an intention to attempt theft in my chamber which is located attached to the north side wall of Dabgram 2 Gram Panchayet office which is only 50 meters away from your Out-post.

This is to be mentioned here that, the said premises/ Chamber is a litigated property which suit is pending before the Ld. Civil Judge Jr. Division at Jalpaiguri, and I am the injunction holder of the pending suit, being Title Suit NO. 722/2025.

That, as I have found on the CCTV footage of my chamber, and gathered information from the witnesses nearby that, one women tea seller who has a temporary stall exact left side of my chamber where the husband of land lady named by Gobinda Das, of the said suit was present and ordered someone to do something at 8.35 pm as per CCTV footage and after sometime at 09.01 pm someone from the upper side of the tin-shade of my chamber forcefully heated the aladbaster sheet with a long iron pipe and broke down the aladbaster sheet and tried to enter to my chamber, facing the CCTV sound those theft left the place.

I, have seen the pipe which has been used to break my chamber at the back side basement near the drain of the house of the land lady namely Manju Das at 10.45 to 10.50 am, but at 11.56 while I went there to inspect through the back side passage of the panchayet office I found it wasn't there.

Therefore this is my request to you that, kindly inspect the location and take necessary action against the culprits.
