In producing herewith one accused person namely- Suresh Rana (59 yrs) S/O late Jagbir Rana of Sevoke road near Alisan Hotel, Ward No. 43 , PS- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:


1. 15 (fifteen ) sealed Bottles of 70 up country spirit each bottle containing 300 ML each , amounting of Rs.50/- each,

I, ASI Dhruba Mishra of Siliguri PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 25.03.26 at 18.15 hrs received a source information that one person namely Suresh Rana (59 yrs) S/O late Jagbir Rana of Sevoke road near Alisan Hotel, Ward No. 43 . PS- Bhaktinagar, Dist- Jalpaiguri was selling in a shop situated at Sevoke road near Alisan Hotel under Bhaktinagar PS with huge amount of liquor illegally for his wrongful gain. This refers to Bhaktinagar PS GDE no- 1367 dated 25.03.26. I informed to I/C Bhaktinagar PS about the above mentioned information. As per order of I/C Bhaktinagar PS, I along with ASI Dipak Karmakar and other force proceeded to Sevoke road near Alisan Hotel under Bhaktinagar PS to work out the information vide Bhaktinagar PS GDE No. 1368 dated 25.03.26. At 18.45 hrs we reached at the spot, being identified by the source our police party found that the above noted mentioned person was busy to sell liquor to his design customer. On seeing the police party all consumed person managed to flew away but we managed to apprehend the above noted person. On being asked he disclosed his identity as noted above. On searched the above noted seized articles as per seizure memo was found from his possession. On further interrogation he failed to produce any valid documents in respect of above noted mentioned seized articles. On further interrogation he became nervous and admitted his guilt before us and stated that he sold the same to her design customers since long for his wrongful gain. Accordingly, I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and label and took signature of the accused person as well as witnesses duly signed by them. The seizure was made between 19.25 hrs to 20.15 hrs. I arrested the said person u/s 35(1) of BNSS after issuing a Memo of arrest appraising the ground of arrest in presence of witnesses as he violated the norms of Bengal Excise Act. The whole seizure process was recorded under Audio and Videography.

I therefore request you a specific case may kindly be started against the accused person namely Suresh Rana (59 yrs) S/O late Jagbir Rana of Sevoke road near Alisan Hotel, Ward No. 43 , PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law.
