Subject: Application for Registration of Case and filing FIR against Illegal Occupation, damaging and Unauthorized Use of Land

Sir,

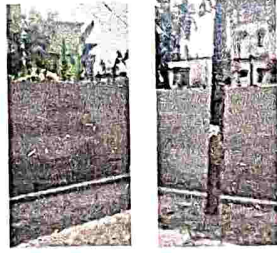
I, Ananta Kumar Bhuti, owner of the land under Ward No. 46, located at Darjeeling District, Block – Siliguri Town, Mouza – Mandlaguri, Khatian No. 3704, Plot No. 4655, had reported encroachment of land on 25th February 2026. GDE was filed in Pradhannagar police station against that incident. The registered GDE number is. 1577.

I wish to bring to your notice that During the site visit of the land Ms Sonali and the scrap business owner had promised to vacate/clear the scrap articles from the land with immediate effect starting from 25th February 2026. The occupants were least bothered to remove the articles and have failed to comply.

It was agreed by Ms. Sonali Bhuti and the Scrap business person, that the land would be vacated by the evening (4:00 P.M) of 27th February 2026. However, the land remained occupied with scrap materials for next several days. Despite promising in front of police officer to vacate the land by 27th February 2026, they have intentionally failed to do so. The land remains occupied with scrap materials, causing me inconvenience and concern. They have even constructed boundary wall on my land without my consent.

During the on-site police enquiry on 25th February 2026 it was found that my neighbour, Ms. Sonali Bhuti confronted and agreed that she had rented out my land to a scrap business owner without my consent. Both Ms. Sonali Bhuti and the scrap business owner are involved in this illegal and unauthorized use of my land for their business purpose.

Despite the previous incident of encroachment, our neighbour Ms. Sonali Bhuti and her son have crossed all the limits and damaged our newly constructed wall without any intimation. **Furthermore, on 23rd March'26 during the construction of the wall Ms Sonali Bhuti and her son have misbehaved and used completely unappropriated languages/Phrases against my wife and me publicly, and we have faced continuous difficulties and obstructions.** Moreover, as a senior citizen to ensure a peaceful life, I would like to report this incident immediately against Ms Sonali and her son without a second thought of considering them for the second time.



Now understanding the nature of my neighbour, I would like to file a FIR to prevent my property from further damage and to protect ourselves as we have the right to live with dignity. Their aggressiveness shows clear intention of encroachment and It is becoming life threatening for us that they become aggressive for encroachment of my land.

I request you to kindly register a FIR against Ms. Sonali Bhuti, her son and the scrap business owner for their illegal activities and unauthorized occupation of my land. Their continued occupation and ignorance, demonstrate negligence and disrespectful mind set and attitude towards law and order.

I request you to kindly register a FIR against the defaulters, Ms. Sonali Bhuti, her son for encroachment and damaging our property. and file a FIR against scrap business owner for unauthorised business activity at our land.

Thank you for your prompt and continuous attention to this matter.


