Respected Sir,

I, ASI KRISHNA MOHAN JHA, S/o Late Girbal Jha, presently posted at Islampur Court under Islampur PD, r/o Ram Krishna Colony, Road No. 02, Ward No. 47 of S.M.C., P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, (W.B.) pin- 734003 would like to inform you that I am currently working in Islampur Court and I used to travel there regularly from my home address mentioned above. Today I came back home at 03:30 PM from my workplace and when I was resting in my house at that time 4 persons namely i) Deep, ii) Sanjay Kamti, iii) Satpal and iv) Sambhu came to my house and started abusing me and my wife with filthy languages, when I objected/protested them for this behavior they locked my wife in room and then dragged me out of my house by grabbing the collar of my t-shirt and started assaulting me mercilessly by fist, blows and kicks me by which I fell down and also hit me on my head with the help of an iron rod along with metal knuckles by which I sustained serious injuries on my entire body including my head. Thereafter they snatched cash amounting to Rs. 2,000/- (Rupees Two Thousand) from my pocket. They threatened me that neither police nor any court of law can do anything against us and told me "police mera kuch bhi nahi bigar sakta hain aur police/thana ko hum job mein rakhte hain, tumko jaha jana hai jao". At that material point of time some local people gathered there and rescued me from them and if these people would not have come I would have been died today on the spot. Thereafter some people brought me to the Siliguri District Hospital for my treatment where doctor gave 3 stitches on my head and did there medical treatment for my recovery. It is pertinent to mention here that all the said miscreants are still standing in-front of my house waiting for me to kill me

along with the dangerous weapons to complete their intention which they had failed at previous time due to the intervention of the local people.

Sir, now I am in an acute fear and an insecure position that some big incident may happen any time even loss of life, so considering the grave situation which is very much imminent within a short span. Therefore, I would like to request you that kindly to investigate the matter thoroughly and punish the miscreants as per provision of law.
