I Md. Firdosh Hussain son of Md. Abid Hussain, resident
of Ashraf Nagar Masjid Road, Ward No. 40, P.S. Bhaktinagar
Siliguri - 734006. I would like to lodge a complaint
regarding the unfortunate suicide of my brother,
Md. Shakib Hussain, S/O Md. Abid Hussain, on 25/03/2026
at my own Residence.

I regret to inform you that my brother took this extreme
step after being under severe mental stress and emotional
harassment allegedly caused by a girl named Aaliya Sheikh
(Kajal Khatun) D/O, Md. Alam, resident of Ashraf Nagar, Masjid
Road, W.No-40, P.S. Bhaktinagar, Siliguri-06. For the past
1 month, she had been continuously disturbing and mentally
harassing him, which deeply affected his emotional
well-being.

Despite our support, he couldn't cope, and we believe
continuous mental harassment led to his suicide, she
was also on call with him during that time.

I request a thorough investigation and appropriate
legal action, I will fully cooperate and provide any
required details.
