Subject : Complaint regarding violation of norms during Ram Navami procession

Sir,

I ASI Nilam Swarnakar, presently posted at New Jalpaiguri Police Station under Siliguri Police Commissionerate beg to state that today on 27/03/2026 I was detailed to perform law and order duty on the occasion of Ram Navami vide SPL CC No-823 Dated 27/03/2026 for procession/program was conducted within the jurisdiction of New Jalpaiguri Police Station. During the said program the by an unknown organizing committee/participants were found using high-volume DJ sound systems, displaying lathi, swords and other sharp cutting weapons, and carrying other prohibited instruments in public.

It is further submitted that such activities were carried out in clear violation of the directions issued by the Hon'ble High Court regarding maintenance of law and order, prohibition on use of DJs, and restriction on display or carrying of arms during religious processions.

The program acts not only contravened the lawful orders but also had the potential to disturb public peace and tranquility in the area which were endanger to human life. As the identities of the organizers and specific participants could not be ascertained at the scene of the occurrence, they are hereby referred to as unknown persons/committee.

Therefore, I pray before you that a specific case may kindly be registered against the unknown committee/persons involved for violation of the Hon'ble High Court's orders and necessary legal action may kindly be taken accordingly.
