In reference to above, I am forwarding herewith the Zero FIR along with complaint of Smt. Susmita Chakrabarty D/O Manik Chakrabarty of Vill + P.O. Langalgram, P.S. Boxirhat, Dist. Cooch Behar, lodged a written complaint against accused persons namely (i) Tapas Goswami S/O Lt. Shekhar Goswami, and (ii) Dulu Goswami, W/O Lt. Shekhar Goswami both are of 1 No. Dabgram, Park Street, Ward No. 23 of SMC, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, PIN-734006 to the effect that she was married to accused Tapas Goswami on 25.11.2020 according to Hindu rites and customs, along with gold ornaments and other household articles, and thereafter started her conjugal life. After the marriage, she was allegedly subjected to mental and physical torture by her husband. During their conjugal life, they were blessed with a male child on 29.12.2021. Subsequently, accused Tapas Goswami left the complainant at her paternal house. Ltr, the complainant returned to her matrimonial home along with her son and resumed conjugal life with her husband. However, after a few days, she was again allegedly assaulted by the above-mentioned accused persons and was driven out from her matrimonial home along with her son. Finding no alternative, she took shelter at her parental house.

As the entire incident took place at 1 No. Dabgram, Park Street, Ward No. 23 of SMC, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, so it reveals that the entire PO of the case falls under the jurisdiction of Siliguri PS, Dist. Darjeeling (Siliguri Police Commissionerate) I am registering a Zero FIR and forwarding the same for further legal action.
