Respected Sir

I would like to bring to your kind notice that a theft incident has occurred at our under-construction apartment site located at 2nd floor, White Nest Building, Opposite Payel Cinema, (Behind Style Bazar) Sevoke Road, Siliguri.

On 26.03.2026, between 3.10 am and 4.30 am, unknown person(s) unlawfully entered the premises and stole electrical wires at the construction site. The materials stolen are of significant value and are essential for the ongoing construction work.

The site is currently under the supervision of our appointed security agency M/s Life Group Associates Security Service, Binay Chowdhury Sarani, Jyoti Nagar, Sevoke Road, Siliguri.

Despite security arrangements, the incident took place during the above-mentioned time period, which raises serious concern.

We have reviewed the CCTV footage installed at the site, and the incident has been clearly captured. The video recording shows the act of theft and may help in identifying the culprit(s). We are ready to provide the footage to assist in the investigation.


In light of the above, we kindly request you to:
