Subject: - First Information Report.

Respected Madam, Sir

with due respect I would like to lay following few lines for favor of your kind consideration and necessary action. On the evening of 23/03/2026 at around 2:30 PM, my husband's brother namely Shri Devanand Joshi, aged about 58 years, entered my mother in law's house and deliberately spened the almirah having a duplicate key without permission and took all my jewellery items which contained two gold chains and two gold rings weights about 25gm. And a gold coin of approx 10 gm. one silver bowl and a silver glass weight around 300 gm along with cash amount of Rs. 25000/- . Even on an earlier occasion, cash amount of Rs. 5000/- has been stolen away by him.

Along with the above acts, he has been assaulting and using criminal force on mewith the intent to outrage my modesty. He had been assaulting me since a long time constantly and at around around 5 – 6 occassions he want spitted on me by using slangs and verbally abusing me. It is important inform you that my borther-in-law i.e, Shri Devanand Joshi had been previously arrested by Siliguri P.S having G.R. Case No. 4431/2020 under Sections 25 (1)(a) and section 27 of the Arms Act, 1959. However, after being enlarged an bail, he never appeared before the learned court.

I, therefore, humbly request you to kindly look into the matter and take necessary legal action to recover the stolen items and arrest the perpetrator at the earliest.
