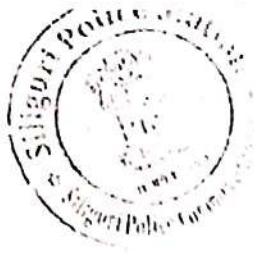

Respected Sir,

In producing here with the three arrested accused persons namely (1) Bajarul Haque (25) S/O Abua Ajimuddin R/O Gorahar, Bisahar, PS- Raiganj, Dist- Uttar Dinajpur, at Present Adarsh Nagar, near Charak Math, ward no- 04 PS- Siliguri, District- Darjeeling (2) Jayanto Roy (23) S/O Bablu Roy R/O Mamata Para, PS- NJP, Dist- Jalpaiguri, at present- C/O Rina Paswan, Hatath colony, ward no- 24 PS- Siliguri, Dist- Darjeeling and (3) Tapash Mahanta (25) S/O Late Ram Mahanta R/O Durga Das Colony, ward no- 20, PS- Siliguri, Dist- Darjeeling along with seizure articles and all connected papers.

I, ASI Minhaj Al Kader of Siliguri P.S. under Siliguri Police Commissionerate, do hereby lodged this written complaint against the above noted arrested accused persons that on 28/03/2026 at about 11.45 hrs I received a secret source information that about 08/10 anti socials being armed with deadly weapons assembled at South Deshbandhu Para, Pipeline, ward no- 30, for making preparation to commit dacoity in a house at South Deshbandhu Para, ward no- 30, under Siliguri PS. Accordingly I diarized the matter in G.D vide Siliguri PS GDE No- 1518 Dated – 28/03/2026 and informed to IC Siliguri PS. As per his direction, I along with ASI Debasish Das, ASI Subir Sen, Constable- 160 Soumen Sarkar and others left PS for South Deshbandhu Para, ward no 30, under Siliguri PS with investigation kit to verify the veracity about the information. At about 11.59 hrs I along with others reached at South Deshbandhu Para, ward no 30 and kept our vehicle at considerable distance from the Pipe Line, and contact with source. Then, as per his guidance I along with others headed towards South Deshbandhu Para Pipe Line, ward no- 30 under Siliguri PS and I looking for independent witnesses if any, but nobody found due to night hours. At 11.55 hrs we reached at South Desh Bandhu Para Pipe Line, ward no- 30 under Siliguri PS and saw a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but we managed to apprehend the above noted three accused persons and others managed to flee away due to darkness. On interrogation they disclosed their Identity as noted above, and they also admitted that they along with 5/7 others assembled at the spot for making preparation to commit dacoity tonight in a house at South Deshbandhu Para, area under Siliguri PS. I accordingly searched them in presence of witnesses and found ; (i) one (01) iron knife with plastic handle measuring approx nine (9) inches recovered from the possession of Bajarul Hoque it was on his hand (2) One (01) Iron Made Knife with wooden handle measuring approx Ten (10) inches recovered from the possession of Jayanto Roy it was on his hand (3) one (01) Iron made rod (Shabol) with one side curved measuring approx Twenty Five (25) inches recovered from the possession of Tapash Mohanta, it was exclusive on the back side of Tapash Mohanta which will be used for committing Dacoity tonight. But somehow the others managed to escape from the spot. Accordingly, I seized the above noted weapons from the exclusive and conscious possession of the attested accused persons, in presence of witnesses under proper seizure list duly signed by them (seizure and lable on 29/03/2026 in between 00.05 to 00.25) with proper video graph. On further interrogation the arrested accused persons also confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at South Desh Bandhu Para Pipe Line, ward no- 30 under Siliguri PS, but others managed to escape from the spot accordingly I arrested them in presence of witnesses as per proper memo of arrest after informing ground of arrest.

From the above noted facts, seizure and circumstance there is a strong reason to believe that the arrested persons are assembled there with deadly weapons making preparation to commit dacoity in a house at South Desh Bandhu Para Pipe Line, ward no- 30 under Siliguri PS.

Therefore, I pray before you to start a specific case against the (1) Bajarul Haque (25) S/O Abua Ajimuddin R O Gorahar, Bisahar, PS- Raiganj, Dist- Uttar Dinajpur, at Present Adarsh Nagar, near Charak Math, ward no- 04 PS- Siliguri, District- Darjeeling (2) Jayanto Roy (23) S/O Bablu Roy R/O Mamata Para, PS- NIP, Dist- Jalpaiguri, at present- C/O Rina Paswan, Hatath colony, ward no- 24 PS- Siliguri, Dist- Darjeeling and (3) Tapash Mahanta (25) S/O Late Ram Mahanta R/O Durga Das Colony, ward no- 20, PS- Siliguri, Dist- Darjeeling & others 5/7 others, as per section of law and to cause its investigation.
