at that time, the 02 (two) brothers namely (1) Md. Ravi
& (2) Md. Juman, both sons of Md. Labif, of
Butcher Pally, Ward No. 6, started abusing him in
filthy languages and when he protested, they attacked
on him wearing iron knuckle punch, and my sweet
husband received severe injury below his left eye
He immediately shifted to Siliguri Distt.
Hospital & treated himself there.

The above noted alleged persons are of very
desperate & dangerous in nature and they have
threatened us for dire consequences.

So, please take necessary action against them
