Respected Sir

We are constructing a residential project in Pradhan nagar under your jurisdiction for last 30 months.

This is for your kind information and necessary immediate action please that today ie 25.03.2026 at around 1.30 pm a group of antisocial elements led by Rikta Chaki, Rumi Singh, Sampa Chakravorty, Anjali Chettri, Krishna Mazumdar, Binota Sundaram, Sandhaya Dasgupta, Molovika Mazumdar, Rikita Biswas along with other members of Jyotirmay Atheletic Club (both man and women wing).

- 1) **Forcefully trespassed** our premises illegally, entered our premises by **breaking** the locking system causing damage to our property. (videos and photos of the same can be provided if required)
- 2) This group **forcefully** removed by **cutting with machines and breaking our CG Sheet and MS Pipes** which enclosed our boundary wall (videos and photos of the same can be provided if required) due to which our site is now fully open without any protection and we strongly apprehend their bad intentions so that theft, burglary, loss and damage can be done of our materials at site in the night.
- 3) They have threatened and **stopped our labour force and daily labours** working at our construction site who out of fear left the site midway causing monetary loss to us as labour wages, cement and bed aggregates which was premixed for work etc.
- 4) They stopped the **unloading of the materials** in our site as a result the pickup carrying 150 bags of tile adhesive returned back midway without unloading and are now asking from us for monetary loss caused to them.
- 5) They also **forcefully snatched forcefully the mobile phone** of our staff who was recording the total incident in a corner without any argument with them.
- 6) The group has further **threatened** us that come what may they will permanently encroach our premises to make a local club adda.

Sir, this group has carried out Illegal and land grabbing activities like land mafias and have no fear in their mind of the law and order of the state.

I request you to book the culprits and put them behind the bars and provide us security so that the peace and tranquility of the area is maintained.
