(i) one yellow and green colour Suitcase containing 30 (thirty) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (30 x 500 ml) = 15 ltrs (Value 30 x Rs 110/- = Rs 3,300/-) - Marked as Exhibit "A" out of which one 01 can Beer taken as sample for examination and marked as Exhibit "A1". (ii) One ash colour back pack containing 36 (thirty six) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (36 x 500 ml) = 18 ltrs (Value 36 x Rs 110/- = Rs 3,960/-) - Marked as Exhibit "B" out of which one 01 can Beer taken as sample for examination and marked as Exhibit "B1". (iii) One blue colour Trolley bag containing 36 (thirty six) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (36 x 500 ml) = 18 ltrs (Value 36 x Rs 110/- = Rs 3,960/-) - Marked as Exhibit "C" out of which one 01 can Beer taken as sample for examination and marked as Exhibit "C1". (iv) One black colour back pack containing 45 (forty five) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (45 x 500 ml) = 22.5 ltrs (Value 45 x Rs 110/- = Rs 4,950/-) Marked as Exhibit "D" out of which one 01 can Beer taken as sample for examination and marked as Exhibit "D1". (v) One yellow colour nylon bag containing 53 (fifty three) bottles of "LODZ POLISH WHISKY" each bottle containing 180 ml i.e total (53 x 180 ml) = 9,540 ltrs (Value 53 x Rs 140/- = Rs 7,420/-) - Marked as Exhibit "E" out of which one bottle of the same taken as sample for examination and Marked as Exhibit "E1". (Total (15 ltrs + 18 ltrs + 18 ltrs + 22.5 ltrs + 9,540 ltrs) = 83.04 ltrs & Total value ( Rs 3,300/- + Rs 3,960/- + Rs 3,960/- + Rs 4,950/- + Rs 7,420/-) = Rs 23,590/-)

Sir,

In producing herewith one accused person namely Lalu Prasad (30 yrs) S/O Ramashish Ray of Jitwarpur, Najamat, PS- Samastipur, Dist. Samastipur, Bihar under arrest along with following articles under proper seizure list viz :-

(i) one yellow and green colour Suitcase containing 30 (thirty) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (30 x 500 ml) = 15 ltrs (Value 30 x Rs 110/- = Rs 3,300/-) – Marked as Exhibit “A” out of which one 01 can Beer taken as sample for examination and marked as Exhibit “A1”.

(ii) One ash colour back pack containing 36 (thirty six) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (36 x 500 ml) = 18 ltrs (Value 36 x Rs 110/- = Rs 3,960/-) – Marked as Exhibit “B” out of which one 01 can Beer taken as sample for examination and marked as Exhibit “B1”.

(iii) One blue colour Trolley bag containing 36 (thirty six) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (36 x 500 ml) = 18 ltrs (Value 36 x Rs 110/- = Rs 3,960/-) – Marked as Exhibit “C” out of which one 01 can Beer taken as sample for examination and marked as Exhibit “C1”.

(iv) One black colour back pack containing 45 (forty five) numbers of Can Beer (HAYWARDS 5000 Premium Strong Beer) each can containing 500 ml i.e, total (45 x 500 ml) = 22.5 ltrs (Value 45 x Rs 110/- = Rs 4,950/-) Marked as Exhibit “D” out of which one 01 can Beer taken as sample for examination and marked as Exhibit “D1”.

(v) One yellow colour nylon bag containing 53 (fifty three) bottles of “LODZ POLISH WHISKY” each bottle containing 180 ml i,e total (53 x 180 ml) = 9.540 ltrs (Value 53 x Rs 140/- = Rs 7,420/-) – Marked as Exhibit “E” out of which one bottle of the same taken as sample for examination and Marked as Exhibit “E1”.

(Total (15 ltrs + 18 ltrs + 18 ltrs + 22.5 lrs + 9.540 ltrs) = 83.04 ltrs & Total value ( Rs 3,300/- + Rs 3,960/- + Rs 3,960/- + Rs 4,950/- + Rs 7,420/-) = Rs 23,590/- )

I, ASI Bikash Roy of Pradhan Nagar P.S, Siliguri Police Commissionerate would like to lodge this written complaint against the above mentioned arrested accused person namely Lalu Prasad (30 yrs) S/O Ramashish Ray of Jitwarpur, Najamat, PS- Samastipur, Dist. Samastipur, Bihar to the effect that today on 31.03.2026 at around 18.05 hrs I received a specific source information that one person is standing at Siliguri Junction near Maa Lodge under PS- Pradhan Nagar, Dist. Darjeeling with 4/5 numbers of bags in his possession containing illegal liquor inside the bags and waiting there for a Bihar bound bus.

Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 1921 dated 31.03.26 and informed the fact to you. As per your kind order and direction, myself along with ASI Anwar Abedin, ASI Prabal Sarkar C/119 Tanmoy Roy and force left for Siliguri Junction by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Siliguri Junction, I informed RT van Officer SI Abir Dhar and requested him to come to Siliguri Junction to accompany with us and also informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, PS- Siliguri Dist. Darjeeling over mobile phone and requested him to come to Siliguri Junction with his camera to videograph the process of search and seizure if required. At around 18.15 hrs myself along with above mentioned officers and force arrived at Siliguri Junction and contacted with two independent witnesses namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Prem Kumar Chowdhury (28 yrs) S/O Nand Kishore Chowdhury of Shiv Nagar, Darjeeling More, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as witness if any search and seizure would be made upon which they agreed. After a while RT van officer SI Abir Dhar arrived at Siliguri Junction and accompanied with us. Then, I contacted with my source and being pointed by the source, I noticed that one person was standing at near Maa Lodge, Siliguri Junction with five numbers of bags in his possession.

Accordingly, we cordoned the place from every corner with due care and caution and managed to detain him with 05 numbers of bags in his possession. Thereafter, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation the detained person disclosed his name and identity as noted above and on further interrogation he disclosed that he is carrying liquor inside the bags in his possession with a view to go to Samastipur, Bihar and waiting there for a Bihar bound bus. Further being searched all the above mentioned 05 numbers of bags under his possession and recovered the above mentioned articles. On demand he failed to produce any valid documents in respect of the illicit liquor recovered from his possession. On further interrogation he stated that he collected the said quantity of illegal liquor clandestinely from one of his suppliers and waiting there for a Bihar bound bus with a view to sale the same in Bihar in high rates. On further grilling, he confessed his guilt and stated that is running such illegal business of illegal liquor since few months for his wrongful gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure list and subsequently arrested the above mentioned detained person namely Lalu Prasad (30 yrs) S/O Ramashish Ray of Jitwarpur, Najamat, PS- Samastipur, Dist. Samastipur, Bihar after observing all formalities of arrest, informing him regarding the ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. I also issued copy of Memo of arrest and ground of arrest in written to him. The entire process of seizure and label has been made in between 19.15 hrs to 20.20 hrs on 31.03.2026 at the spot under the coverage of videography executed by the above mentioned cameraman as per norms of BNSS. Further, I informed his friend namely Sangam Ray over mobile phone having Mobile No 8877900302 (duly provided by the accused person) regarding arrest of Lalu Prasad and also informed that the said accused Lalu Prasad will be forwarded before Ld ACJM, Siliguri on 01.04.26 morning.

I, therefore pray before your good self that a specific case may kindly be initiated against accused person namely Lalu Prasad (30 yrs) S/O Ramashish Ray of Jitwarpur, Najamat, PS- Samastipur, Dist. Samastipur, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
