Sir,
I, ASI Binod Chhetry of Khalpara TOP under Siliguri PS, SPC, do hereby lodge this written complaint against the supporters of "Muslim Nagarik Committee" viz. (i) Shehnaj Hossain, (ii) Md. Chand, (iii) Md. Amir and other 70-80 supporters of that committee, all are resident of Ward No. 06, SMC, PS-Siliguri, Dist.-Darjeeling to the effect that on 31.03.2026 at about 14.20 hrs. credible information has been received from a source that few supporters of a Non Political Organisation under the banner of "Muslim Nagarik Committee" and under the leadership of (i) Shehnaj Hossain, (ii) Md. Chand, (iii) Md. Amir assembled at Ward No. 06 of SMC, Siliguri and showing their protest against the ongoing process of "SIR" (Special Intensive Revision). They are also planning to bring out a rally from there and will proceeding towards Venus More, Siliguri through Hill Cart Road and preparing for blockade the Hill Cart Road. Accordingly I conveyed the same to O/C, Khalpara TOP. This refers Khalpara TOP GDE No. 938 dt. 31.03.26. Thereafter as per his direction myself along with ASI. Dilip Sarkar, C/ 717 Hirak Roy, C/390 Sujit Paul under the leadership of SI. Sandip Dutta, O/C, Khapara TOP rushed to the spot and found that about 70-80 supporters of that "Muslim Nagarik Committee" under the leadership of the above noted persons have started a procession from ward no. 06, SMC, Siliguri and on demand they failed to produce any permission which need to be obtained from the concerned authority to bring out the same. Immediately they have been asked to stop the illegal procession but they did not pay any heed and after arriving at Venus More, Hill Cart Road, Siliguri they started blockading the entire Venus More Chowk & connected roads and blockade the entire Venus More at the busy hours of day from 15.25 hrs which causes total obstruction in free flow of the entire traffic on the such busiest road of Siliguri. As a result vehicular movement has totally chocked from all around of the road and it caused severe inconvenience to the general public thoroughfare. In the mean time I/C, Siliguri PS along with other officers & force from Siliguri PS & Panitanki TOP arrived at the spot with specialised force. Then the supporters of the said Committee were again asked to leave the road as their act was causing obstruction & inconvenience to the general public by the way of their unlawful assembly but they did not pay any heed and continued blockading the road for 15 minutes from 15.25 hrs to 15.40 hrs. Later we succeed to clear the road blockade by dispersing them all.

Hence, under the above noted circumstances, I request you that a specific case under the proper sections of law may kindly be initiated against the above noted (i) Shehnaj Hossain, (ii) Md. Chand, (iii) Md. Amir and other 70-80 supporters of "Muslim Nagarik committee", all are resident of Ward No. 06, SMC, PS-Siliguri, Dist.-Darjeeling who involved in this crime and arrange for its investigation.
