I SRI ANUP CHAKRABORTY,S/O- Sri Ashok Chakraborty resident of ,Haiderpara, Meghlal Roy Road,W/N-40 SMC,Post Office -Haiderpara, District - Jalpaiguri, Pin. 734006 (W.B) most respectfully beg to state that today at about 1 am I along with my friend namely Ranjan Das,S/O- Lt Badal Das went to Error Pub ,situated at Acropolis mall,Sevok Road during stay there about one hour later when pub about to close that time some bouncers started to misbehave with me in presence of their staff without any fault or instigation from my side and as such I asked them why they were doing such in response those bouncer tried to show their force upon me and given instruction to vacate/left the pub immediately .It is a fact they were so desperate at that time and subsequently assaulted me very mercilessly after taking me their separate room which out of their C.C TV Zone .After that I somehow able to saved me .In the mean time police came to the place & rescued me and subsequently my relative came to me after getting the information thereafter I was admitted at the Anandalok Multispecialty Hospital at about 3: 57 am, and after taking proper treatment I was discharged with medical advice from the said nursing home.It is pertinent to mention that I got severely injured as a result their assault my head and others parts of body injured dangerously. During resorted assault me they threatened me that I could not do anything against them as they are most influential in the heart of Siliguri City .

It is my humble request before you to kindly take necessary Legal action against the above said accused person, by invoking appropriate step under provision of law to get rid of such peril for the end of Justice as early as possible,
