Dear Sir/Madam,

My name is PRADIP RAI Son of Pratap Rai, Residing in the Jyotinagar, Word no-41, near pateshwari school, Siliguri-734001.

This is to inform you that on Monday (30/03/2026), an incident occurred with a guest at our premises in Error Restaurant Cum Bar. The guest had been requested to vacate the area as per the permission and rules of the management at 01.55AM. However, despite repeated requests, the guest refused to cooperate and did not vacate the place.

During the process of requesting him to leave, a minor altercation took place and there was a brief physical scuffle between the me. The situation happened around 01:55 AM and immediately we informed the police station, the police arrived immediately thereafter and proceeded to have the premises vacated and under control. At this moment, the guest struck me, and I have sustained a minor injury.

We regret the inconvenience caused due to this incident. Necessary steps have been taken to ensure that such situations are handled more carefully in the future.
