Subject: - F.I.R. regarding illegal implantation of 8 GB Audio recorder in the chamber of Station Manager, Milanpally CCC, WBSEDCL

Sir,

I, Prashanta Kumar Mahato, s/o- Mr. Dilip Kumar Mahato, presently Divisional Engineer and Station Manager, Milanpally CCC do hereby lodge this complaint that on 17th March, 2026 at about 01:30 hours, one 8 GB Audio recorder was found in the chamber of Station Manager, Milanpally CCC by undersigned behind the red coloured chair kept in the chamber of Station Manager. On 18th March, 2026 at around 10:30 am, it was verified from several staff, security guard and agencies working at Milanpally CCC but no one could recognise the same. A letter was issued by staff and workers of Milanpally CCC for fair investigation of the case on 18.03.2026 which are submitted along with complaint done (reference given above) on 18.03.2026. The footage of CCTV from 15.03.2026 to 17.03.2026 was desired by Siliguri Police Station for proper enquiry which was submitted to Siliguri PS on 19.03.2026.

As per CCTV footage the following suspicious activities are noticed:

1. Mr. Abhijit Bishnu, Sr. Office Executive of Milanpally CCC was seen to enter the chamber of Station Manager between 09:00 am to 10:00 am on 16th March, 2026 and following activities are noticed:

- He was found to examine the chamber of Station Manager in suspicious manner.
- He took one chair outside the chamber of Station Manager.
- He re-entered the office premises and kept on searching the chamber in suspicious manner.
- He re-installed the chair in the room of Station Manager.

2. Mr. Abhijit Bishnu was again seen to enter the chamber of Station Manager after office hours between 06:30 pm to 07:30 pm on 16th March, 2026 and following activities are recorded:

- He entered the premises of Station Manager without switching on the light and examined the back side of chair in suspicious manner.
- He then re-entered the chamber of Station Manager took the chair outside room and re-installed the chair without switching on the light.

3. On 17th March, 2026, the undersigned visited the office for restoring dockets due to storm on previous night and recovered the Audio recorder from the back side of chair between 01:00 pm to 02:00 pm where the suspect was noticed repeatedly.

It is high suspected that Mr. Abhijit Bishnu has installed the spy audio recorder inside the chamber of Station Manager.

You are requested to treat this as an FIR as start an investigation regarding the same.
