Subject: Complaint regarding housebreaking and targeted theft at Ward No. 6,
Dangipara, Siliguri.

Respected Sir/Madam,

I, Rahul Ghosh, son of Shri Sankar Ghosh, resident of Ward No. 6, Dangipara,
Siliguri, wish to report a major incident of housebreaking and theft at my residence.

1. Incident Details:

My family and I were away from our residence from the morning of March 16, 2026,
until today, March 30, 2026. Upon returning home today at approximately 9:00 AM, I
discovered that the lock to our main collapsible gate had been tampered with and was
wide open. All subsequent entry gates were also found open, and the entire home had
been thoroughly ransacked.

2. Items Discovered Missing (Preliminary List):

While we are still in a state of shock and are currently in the process of ascertaining the
full extent of our losses, the following items were immediately identified as stolen:

- **Cash & Valuables:**
 - Cash amounting to approximately ₹2,50,000/- (Two Lakh and Fifty Thousand Rupees).
 - A collection of various currency coins.
 - Original wedding jewelry belonging to my wife (Monalisa Ghosh), including our wedding rings and gold necklace.
- **Sovereign & Identity Documents:**
 - Original Indian Passports belonging to me and my wife (Monalisa Ghosh).
- **Total Security Breach (Keys):**
 - Approximately 15 sets of original keys for various internal locks, almirahs, and drawers within the house.
 - The spare scooter keys for vehicles registered as WB74BS8223 and WB74BM6540.
- **Original Property & Business Files:**

- Original Title Deeds for properties located at **Sevoke More, Hill Cart Road, and Bharatnagar.**
- Original **Bainanama (Sale Agreement)** for Land near **Kawakhali School.**
- Various other property deeds and land records (RS/LR Porcha, Khatian, and Dag information) for land and project which I am yet to fully ascertain.
- Original lease agreements and correspondence for commercial premises at **Sevoke More and Hill Cart Road, Siliguri.**

3. Theft of Critical Legal Evidence:

Most significantly, a specific set of **original signed apology letters** and related documents dated approximately 15 years ago have been stolen. These letters were issued by **Mr. Rathin Ghosh** as an admission of liability regarding a previous incident involving the theft and return of approximately 15 to 20 files regarding property and land similar in nature to the ones found missing today, from my office then located at **277, Hill Cart Road, Radhika Bhawan, Siliguri.** These documents are of immense evidentiary value in ongoing property litigations.

4. Apprehension of Criminal Framing:

We hold a grave and immediate concern regarding the theft of our **spare vehicle keys.** We fear these keys will be used to plant contraband or illegal arms in our vehicles to falsely implicate me and my family in criminal cases. We request that this apprehension be formally recorded.

5. Request for Action:

Given the sensitivity of the stolen documents and the total compromise of our home security, I request you to **register this FIR** under the relevant sections of the **Bharatiya Nyaya Sanhita (BNS)** for housebreaking and theft and take immediate steps against the miscreants.

I must emphasize that this list is incomplete as we are still identifying missing items while dealing with the shock of this incident. I will provide a **supplementary list** of any further missing items as soon as our inventory check is complete.
