Sir,

In producing here with the one arrested accused person namely Rintu Ghosh 39 yrs S/O Late Naren Ghosh R/O- Nirmal Chowdhury Satani, Bidya Chakra Colony, ward no- 44 PS- Bhaktinagar, Dist- Jalpaiguri along with the seized articles, with all connecting papers.

I ASI Rabin Lama S/O- Birendra Kumar Lama of Siliguri PS under Siliguri Police Commissionerate do hereby lodge a written complaint against the arrested accused person namely Rintu Ghosh 39 yrs S/O Late Naren Ghosh 39 R/O- Nirmal Chowdhury Satani, Bidya Chakra Colony, ward no- 44 PS- Bhaktinagar, Dist- Jalpaiguri to the effect that on 01.04/2026 at about 18.25 hrs received a secret source information that one person namely Rintu Ghosh is storing and selling huge quantity of liquor illegally on his shop, located at Bagrakote, near local Bus stand ward no- 18, under Siliguri PS. The fact was diarized in G.D (vide GDE no- 44 Dated- 01.04.2026), accordingly informed to IC Siliguri PS and as per his direction, myself along with ASI Debasish Das, ASI Minhaj Al Kader, Const- 160 Soumen Sarkar of Siliguri PS left for Bagrakote, local bus stand, to verify the veracity of the information. At about 18.40 hrs I along with my accompanied officer and force reached at Bagrakote and kept our vehicle at considerable distance from the spot and on being shown and identify by the source, I along with my accompanied team held raid in the said shop of Rintu Ghosh and managed to apprehended the said person. On searched I recovered Fifteen (15) bottles of Himalayan gold 60 up Country spirit each bottle containing 600 ml, (total 9 liters). (Total value of RS/- 170 X 15 = Rs- 2550/-) which is containing in a paper cartoon of box. On interrogation he disclosed his identification as Rintu Ghosh 39 yrs S/O Late Naren Ghosh R/O- Nirmal Chowdhury Satani, Bidya Chakra Colony ward no- 44 PS- Bhaktinagar, Dist- Jalpaiguri. On demand he failed to produce valid license or documents in r/o said liquors. On further interrogation he admit his guilt and stated that he sells liquor to his design customers without valid licence or documents for his wrongful gain. Accordingly as he violated the rules and norms of Bengal excise act, as such I seized the same viz Fifteen (15) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (total 9 liters) and each bottle M.R.P Rs- 170/- (Total value of seized articles 15 X 170 = Rs- 2550/-) from the exclusive and conscious possession of Rintu Ghosh 39 yrs S/O Late Naren Ghosh R/O- Nirmal Chowdhury Satani, Bidya Chakra Colony ward no- 44 PS- Bhaktinagar, Dist- Jalpaiguri (searched, **seizure and labelled was made in between 18.45 hrs to 19.10 hrs**) the whole processes of search and seizure was made under video graphed in presence of available witnesses, duly sign by the accused as well as witnesses. Then I arrested him u/s 35(1) of BNSS after appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Rintu Ghosh 39 yrs S/O Late Naren Ghosh R/O- Nirmal Chowdhury Satani, Bidya Chakra Colony ward no- 44 PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law.
