SUB:-F.I.R. against my husband,in-laws and my uncle and cousin brother member for committing physical and mental torture upon me due to demand of dowry and other unjustified reason.

Respected Sir/Madam,

With due regards, I, SmtAlokananda Chakraborty, D/O Lt. Chunnilal Chatterjee, W/O Sri Arindam Chakraborty, presently residing at RenukalayaAppartment, Hemanta Mukherjee Sarani, Deshbandhu para, P.O. & P.S. Siliguri, Dist- Darjeeling, would like to lodge this written complaint to the following effects:

1. That my marriage was solemnized on 07.03.2001 as per the provision of Special Marriage Act, 1954 vide Serial No. 64/2001 with Sri Arindam Chakraborty. S/O Lt. Ashwini Kumar Chakraborty, residing atAsiyanaApartment, A.M Bose road, Deshbandhu Para, 27 No Ward Siliguri, and subsequently on 08.12.2001, we solemnized our social marriage from my father house situated at Kabbik, Sree Ma Sarani, Opposite Daffodils School, Babupara, P.O. & P.S. Siliguri, Dist- Darjeeling.
2. That my husband is a Govt. Doctor (Dentist) at present posted at Hill Govt. Hospital, Balurghat.
3. That at the time of my marriage, my parents and other nearest relatives had given so many valuable articles as like gold ornaments measuring 250 gms, silver plate and glasses measuring 2 kg, including cash amounting to Rs. 1000000/- only and other household articles for my better future life as per demand of my husband and in-laws.
4. That after my marriage, I along with my husband, lived and co-habited together as husband and wife in my matrimonial house situated at Sharada Kunj, Prilata Waddedar, Deshbandhu Para, Ward NO-27 Siliguri and out of our wedlock, I gave birth one male child on 05/04/2003, whose name is Anirban Chakraborty.

5. That just after few days of our marriage, my husband have started physical and mental torture upon me on the demand of more dowry and when I refused to bring any money from my parents, my husband have started to torture me both physically and mentally on a false and fabricated allegations.
6. That day by day, the torture of my husband increased and my husband always insisted and encouraged me to bring money from my parents and when I refused to do the same, he did not bother to assault me physically.
7. That since 2004 my husband reduced to provide my basic requirements and subsequently I came to know that my in-laws namely (1) Tapon Chakraborty (brother-in-law) (2) Paromita Chakraborty, W/O Tapon Chakraborty, (3) Swapan Chakraborty (4) Rina Chakraborty, W/O Swapan Chakraborty, (5) Gita Bidyananda, (6) Babla Neogi (7) Raju Neogi, (8) Tridep Bidyananda, (9) Tandrma Chakraborty, (10) Krishna Hajarika and (11) Suresh Hajarika, resident of Kaziranga Apartment, Flat no-104/B, Ananadanagar Lane no-4, Adabari Tiniali, Po-Pandu Sub Post office (Rest camp), Dist-Kamrup, Guwahati (M), Assam-781012 all are behind the conspiracy and they are used to do frequent visit in my house and also instigate my husband against me the reason best known to them.
8. That in the year of 2006 my husband sold the house and car which we had bought from the money he received during our marriage with a pretext that he had huge public loan and to re-pay the loan he needs to sell the assets.
9. That finding no other alternative I along with my husband and son moved to my father house and started to reside there.
10. That subsequently one Kabuliwala started to come my father house and used to give threat to my husband and when I asked him why he is doing such behaviour to my husband he stated that my husband taken loan from him amounting to Rs. 80000/- only but he did not re-pay the loan and due to social prestige, my father re-pa the loan amount.

11. That as per demand of my husband my grandfather also give him one Gypsy car.
12. That subsequently I came to know that my husband having multiple affairs and thus he needs huge money for their maintenance and enjoyment.
13. That even I came to know that my husband is an antisocial person he used deal with antique items import and export business without licence and as an when I raise objection against his said illegal acts, he used to beat me mercilessly.
14. That my husband again started an affair with one lady in Alipurduar, who was a nurse in Alipurduar Hospital, finding no other alternative I requested Dr. Minaj to help me, who was a Supervisor in the Hospital and as per advice of Dr. Minaj I gave one written complaint to him and accordingly Dr. Minaj transferred my husband to Hill Hospital, Dist- Balurghat.
15. That my husband is a habitual drunker and he used to come in the home in late hours with a fully drunken condition and started torture upon me and when I started to raise objection against his said habit, then he started to misbehave with me and also started to use filthy and offensive languages upon me.
16. That I have passed my mental life with my husband and in-laws members with so many miseries, torture and assault and I used to bear such type of inhuman torture of my husband and other in-laws members with a hope that everything would be settled in near future but they did not stop their said inhuman torture.
17. That subsequently I came to know that my husband again started illicit relation with a patient named, who used to reside near balurghat, hearing the same I along with my brothers went to Hill where my husband used to reside and I found several evidence that my husband maintains illicit relation (I am able to produce the same) and when I raise objection against his said illegal act, he lodged false criminal case against me by influencing his position as Govt. Doctor.

18. That my husband, in collusion with his cousin brother Mr. Sujash Bhattacharjee, who is a railway employee posted at Bokaro Steel City (Jharkhand - 827010) under the South Eastern Railway, Adra Division, and my uncle Mr. Sujoy Bhattacharjee (father of Mr. Sujash Bhattacharjee), presently residing near the Senior Section Engineer, Carriage and Wagon Office, A.C. Railway Area, P.O. Bokaro Steel City, District Bokaro, Jharkhand - 827010, are continuously pressurizing and coercing my mother, Mrs. Madhumita Chatterjee, to sell her house for their vested financial interests.

19. That my mother is mentally and physically vulnerable, as she is still coping with the recent demise of her only son, Late Dhruvo Chatterjee, which has severely affected her health and emotional stability.

20. Taking undue advantage of her vulnerable condition, the said persons are persistently influencing and instigating my husband to harass me and my son, both mentally and physically, in order to force compliance with their unlawful financial demands.

21. That thus in this way my husband and my above-named in-laws continuously doing torture upon me by physically and mentally and my son is the best witnessed of the above incidents. My Husband (Arindam Chakraborty) suddenly visited the residence of Siliguri, and started abusing me in filthy language under intoxicated state, he further forced me to sign over a blank paper. He has also threatened me not to raise claim for any financial support else he will file a case against my son which may ruin his upcoming career forever.

I, therefore, requesting you to investigate in to the matter and please take necessary legal steps against my husband and other in-laws' members as per the provision of law and obliged thereby.
