Respected Sir,

I RUBI PAUL, Wife of Tapash Deb, Daughter of Abhay Paul, aged about 25 years, Shivmandir, Shadan more, Backside of Radha Ranjan Primary School, P.O. : Kadamtala & P.S: Matigara , District : Darjeeling 734011 beg to state as follows:

1. That my marriage was arranged with one TAPASH DEB, aged about 48 years, Son of Late Amal Deb, Employee at WBSEDCL Electric office, Shiva Mandir, P.O : Kadamtal & P.S.: Matigara who is a residence of Shivmandir, Shadan more, Backside of Radha Ranjan Primary School, P.O.: Kadamtala, P.S: Matigara District : Darjeeling on 08/12/2022 according to Hindu Rites and customs at Anandamay KaliBari, near Kalibari Road, Mahabiristhan, P.O: Siliguri Town, P.S: Siliguri, District: Darjeeling, West Bengal, PinCode: 734001 in presence of both the family members, relatives, friends and well-wishers.
2. That when the marriage was fixed my husband and his family demanded huge dowry from my father and as per their said demand my father gave one gold finger ring to the groom i.e.; my husband and one set of gold earring, one gold necklace, one gold finger ring and Rs. 50,000/- in cash (Rupees Fifty Thousand) on the day of our marriage. And it is important to mention here that my husband and his family hid his actual age and we were told that he is 33 years old at the time of our marriage.
3. That after marriage I started residing at my matrimonial home at Amtala Chayan Para, P.O.: Ghugumali, P.S.: Bhaktinagar, District: Jalpaiguri, West Bengal, Pin code: 734006 with my husband, my mother-in-law named by Usha Deb, brother-in-law named by Abhijeet Deb.
4. That after my marriage on reaching my above-mentioned matrimonial house my above-named mother-in-law and sister in laws named by Anita das, w/o Amit Das, resident of Debidanga, Champasari, P.O.: Champasari, P.S.: Pradhan Nagar, District: Darjeeling (W.B.), Pin Code: 734003 and Nilima das, W/o Late Sujit Das, Contact no.: 9339089262 (Anita Das) were really upset and started telling me that "Your parents did not spend anything in your marriage, you came from very low standard family having no social prestige at all, we are unfortunate that we arranged our son's marriage in

such a family" in front of other relatives, I somehow turned all the tortures as was clocked on the very first day.

2. That since the day of my marriage my husband namely Taposh Deb never spoke to me politely rather he pressurized me to bring money from my father when I resisted my husband and my mother-in-law and brother-in-law stopped giving me food and assaulted me mercilessly.
6. That in between all this mental and physical tortures from all of them, my husband kept on pressurizing me to ask for cash from my father knowing the fact that my father was suffering from several illness and at that point of time he was unemployed to create more pressure he used to physically torture me and rape me every single night. When I talk about it to my mother-in-law she threatened me by saying that if I disclose this to my parents or anyone else then they will kill me and no one will ever come to know and used filthy language towards me on a daily basis.
7. That in the month of July 2023 when I got to know that I am pregnant, feeling excited I showed this good news with my husband and my mother in law and brother in law, they started to taunt me for conceiving so early and during my pregnancy I was forced to do household work despite my condition was not well as I was not given adequate amount of food and other medical assistance.
8. That during my last pregnancy also my husband used to force me to be sexually active which he knew was very dangerous for the unborn child and as my repeated denial of his demands when I was about eight months pregnant, I was forcefully sent to my parental home and gone back to my son on dated 01-04-2024 at Madhav Clinic and Nursing Home, Bhubaneswar. After the birth of my child, I repeatedly requested my husband to take me back to my matrimonial home but he dropped me to my parents' home after my discharge from the nursing home. Later in the month of July my parents took me and my son to my matrimonial house and requested my husband and my mother-in-law to let us stay there to which they agreed.
9. That later at the time of Durga puja my husband took me to my parents' house and asked me to stay there for few days as our son had cold and if I stay at my matrimonial house I would catch cold too and it will worsen the condition of the child as he has an acute fever, so it would be better if I stay at my parents' house and take rest for few days from household chores. But to my surprise he never came to take me and our son to my matrimonial

house. And meanwhile they had sold their house and shifted to their new house at this month, about which I didn't have any information.

10. That on repeated request to my husband by me and my parents on 2nd May 2025, my husband and my brother in law came to take me back to my matrimonial new house and when I reached the new house at Sadhan more Shri Mandir, back side of Radha Rajgan Primary School, on our arrival my mother-in-law and mother-in-law named by Anita Das refused to allow me to enter, pushed and humiliated me and my parents in front of everyone and threw all my cloths and belongings on the road and told me never come there and leave them permanently. Later my husband and my brother-in-law also joined them and started using filthy language towards me and my mother. Having no other option and seeing my son hurting me in tears I left the place and return back to my parents' house.
11. That it is pertinent to mention here that since on several occasions I reached out to my husband to take me and my son back to my matrimonial house but he refused to do so. He did not even give a single penny for our son, knowing the fact that my father's financial condition was very poor. Finding no other option, I had to start working at medicine shop at HR Cart Road on a minimal salary of Rs. 6000/- dated 01-07-2025, just for my son's survival and basic necessity for my son. I worked there for 6 months then as my son was just a year old it was difficult for him to stay without me and as I had to leave the job in the month of December 2025.
12. That on 15 March 2026, hoping to restore my matrimonial life peacefully, I again went to my matrimonial home. However, my husband and all my in-laws continued their cruelty and harassment and even denied proper food and basic necessities to me and my unborn child, causing severe mental and physical suffering but for the sake of my child I was ready to bear all their tortures.
13. That on 05-05-2026 at night when I was sleeping with my son my husband as always started to harass and forcibly tried to rape me in front of my 2 year old son, seeing his behaviour my child woke up from his sleep and

started to cry, I was shocked to see that my husband took a pillow and
on our son's face in an attempt to suffocate him and cause his d
Hearing the distressed sound of my child, I immediately rushed to save
and I somehow managed to remove the pillow from his face and rescue
child, thereby saving his life. Being terrified for the safety of me and my
, I was compelled to flee from the matrimonial home on 21 March 2026
with my minor child as I was unable to bear such cruelty any longer
took shelter at my parental house where I am presently residing. Till
they are threatening me with serious consequences if I approached the p
or took legal action against them.

I therefore kindly request you to take necessary action against
aforesaid culprits as per the said law.
