Subject: Suo Moto Complaint against Akash @ Amit Kr. Jha & Abhijit Roy and others regarding assault, criminal trespass, threats, and disturbance.

Sir,

In producing herewith two arrested accused persons namely Akash @ Amit Kr. Jha (27 yrs), S/o - Adhir Kumar Jha, R/o - Kawakhali, Bidhan Pally Road, P.O. Sushruta Nagar, P.S. Matigara, Dist - Darjeeling & Abhijit Roy (23 Yrs), S/o - Monjit Roy, R/o - Vill - Rangapani, Paschim Para, P.O. Rangapani, P.S. Bagdogra, Dist - Darjeeling to the effect that I was entrusted to enquire into a mass petition vide NBMC OP GDI No. 993 dated 27/03/2026, submitted by Azaruddin Md. and 79 others, regarding alleged hooliganism by certain members of a Ram Navami procession at Kawakhali Madrasa and adjoining cemetery area under NBMC OP, P.S. Matigara.

Upon enquiry, it has been revealed that on 27/03/2026 at about 15:00 hrs, the accused persons, namely Akash @ Amit Kr. Jha and Avijit Roy, along with their associates, unlawfully entered the premises of the local Madrasa and cemetery and started to damage the pillar and gate of the Madrasa and tried to hoist their orange flag on the madsara gate. They also started abusing, threatening, and intimidating the inmates and local residents without any provocation.

They used highly offensive language, attempted to incite communal tension, and created panic in the locality. When the local residents tried to resist or pacify the situation, the accused persons became more aggressive. They also issued threats of dire consequences, thereby putting the victims in fear for their lives and safety. Such acts have severely disturbed public peace and communal harmony in the area.

During further enquiry on 28.03.2026 it is revealed that accused person namely Akash @ Amit Kr. Jha, Abhijit Roy & others is directly involved in this incident. Accordingly I hold raid at Kawakhali area and apprehend the accused person namely Akash @ Amit Kr. Jha (27 yrs), S/o - Adhir Kumar Jha, R/o - Kawakhali, Bidhan Pally Road, P.O. Sushruta Nagar, P.S. Matigara, Dist - Darjeeling & Abhijit Roy (23 Yrs), S/o - Monjit Roy, R/o - Vill - Rangapani, Paschim Para, P.O. Rangapani, P.S. Bagdogra, Dist - Darjeeling on interrogation they confessed their guilt before me, accordingly I arrested them under proper memo of arrest on the ground of u/s - 35 BNSS.

In view of the above, this suo moto complaint may be lodged against the accused persons under proper section of law for taking necessary legal action.
