Sir,

With due respect and humble submission I SI Manoj Kr. Roy of Matigara P.S do hereby lodge this written complaint to the effect that today on 29/03/2026 I was deputed to perform K33 patrolling van duty along with force, since 08.00 hrs vide Matigara P.S. M.C.C. No.861/2026, Dated 29/03/2026 and Matigara P.S. GDE No. 2589, Dated -29/03/2026 in course of said duty I have received a source information that one Tractor is coming from Balasan River loaded with River bed Materials towards Matigara Bazar which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Amtala under Matigara Ps we found one Tractor bearing Regn. No. WB 73 G 4426 loaded with river bed materials was speedily running toward Matigara Bazar. We managed to stop the vehicle and on demand the driver/owner of the vehicle could not produced any valid document in respect of the said loaded materials. It is crystal clear that the driver/owner of the vehicle (Tractor) bearing Regn. No. WB 73 G 4426 is procured the river bed materials from somewhere clandestinely and was preceding to sale the same to their designated customer for their wrongful gain. Accordingly I seized the vehicle having Regn. No. WB 73 G 4426 loaded with River Bed Materials with properly seizure list followed u/s 105 of BNSS and also arrested the driver of the seized vehicle namely Hridoy Barman (20 Yrs/Male) S/O. Kanta Barman of Rananagar, P.S. Matigara Dist. Darjeeling. Brought the seized vehicles to Matigara P.S and kept at P.S Compound and the arrested accused kept into the P.S Lock up after mainlining proper Hazat rules. The Seizure was made in between 09.03 hrs to 09.10 Hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be registered against the accused driver of the seized vehicle namely Hridoy Barman (20 Yrs/Male) S/O. Kanta Barman of Rananagar, P.S. Matigara Dist. Darjeeling and arrange for its investigation.
