Respected sir,

I would like to bring to your attention a serious issue
concerning a person named prasangit Dair he is been
consistently creating nuisance and disturbing the peace
of the neighbourhood and his mother Gita Dair is supporting him always.
This person has done this very frequently. uses abusive language
slang, and behaves in an aggressive and unacceptable manner.
Despite repeated complain to police nearly 8 to 10 times
we have lodge a complain and thereafter he has been
always released up. We have done a meeting with councillor
but their is no inputs.

Today, the situation turned extremely serious when he
verbally abused my father while he was walking in road
and he had throw stone on him. thereafter my mother
knows it and came to ask then my mother was further
assaulted physical by pulling hair and then throw stone
causing injuries. Due to the severity of the incident, my
mother had to be taken to the hospital for medical
treatment.

This behaviour is not only unlawful but also poses a threat
to the safety and well being of my family and others in
locality. If anything happens to them he will be full responsible.

I kindly request you to take immediate action and lodge
a F.I.R against him and request you to take legal
measure... I am also presenting Medical slip.
