Sir,

In producing herewith one arrested lady accused person namely Firoja Begum-41yrs w/o Lt Md Entajul of Dry Fish Market, near three signal, PS Matigara Dist Darjeeling (not verified) along with the following seized articles under seizure as per seizure list:

[i] One (01) plastic zipper packet containing with 101 grams of suspected to be brown sugar & marked as- Exhibit-A.

[ii] One Realme mobile phone having IMEI No-865679073614 & 865679073614302 with sim No-8653758710.

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned lady accused person to the effect that on 01.04.26 at about 13.15 hrs, I received a reliable source input that one lady has gathered with huge quantity of brown Sugar in her house for delivering the same to her designed customers at Bypass, Biswas colony for her wrongful gain. It is reasonably believe that the lady may escape from the scene if Police party did not reach the spot immediately. The matter was diarized in Matigara PS GDE vide No. 25 dated 01.04.26 and subsequently, I informed the matter to the I/C Matigara PS,SPC in writing and being directed by him, At about 13.25 hrs myself along with ASI Bikash Roy, ASI Dipak Chhetri, ASI Chandra Prakash Adhikary, ASI Prabir Karmakar, C/523 Sanjit Kundu, C/868 Sujal Roy, L/C-1316 Chandana Paul & L/C-1286 Anisha Chhetri all of Matigara PS with investigation kit (envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. left for Bypass, Biswas colony under Matigara PS by govt. hired vehicle to verify the veracity of the information vide Matigara PS GDE no. 26 dated 01.04.26 and M.C.C No- 907/26 Dated 01.04.26.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at 13.35 hrs we reached in front of Bypass, Biswas colony and waiting there also I called two independent witnesses namely; (1) Vishal Singh-28yrs (Ph-7501211710) s/o Lt Anupam Singh of Prakashnagar near house of Purosattam Singh, ward no-42, PS Bhaktinagar Dist Jalpaiguri and (2) Nimai Barman-24yrs (Ph-7679098990) s/o Lalmohan Barman of Indrapally, Shib mandir PS Matigara Dist Darjeeling disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure.

At about 13.40hrs I also informed Videographer Somnath Chatterjee (ph-9064648755) s/o Sushil Chatterjee of Aravindapally, Gokhel road, ward no-22 PS Siliguri dist Darjeeling over telephone to remain present at the PO for videography during search and seizure if any.

At about 13.55hrs Videographer Somnath Chatterjee reached at the spot with camera. Being identified by my source we detained the above noted lady with the help of Lady Police personal. We disclosed her identity as police personnel. On being asked she disclosed her identity as noted above. On further examination the above alleged lady stated that she is possessing "Brown Sugar" with her. Being identified by source and the information in hand and stated her that she will be searched for the purpose by lady Police. She admitted that she had illegally possessed brown sugar in her possession for selling the same to her designed customers as per requirement for her wrongful gain.

I then gave an option in writing whether she will willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return she given written reply that she is willing to be searched in presence of Gazette Police Officer. Then at about 14.25hrs I informed over telephone to Shri Manojit Sarkar, Inspector In-Charge, Matigara Police Station to come at Bypass, Biswas colony requested him to presence during search and seizure of the Brown Sugar.

Accordingly at 14.40 hrs Shri Manojit Sarkar, Inspector In-Charge, Matigara Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained lady for conducted following all formalities by Lady Police personal and recovered the above noted articles from the exclusive possession of above noted lady accused. Subsequently, being demanded in presence of Shri Manojit Sarkar, Inspector In-Charge, Matigara PS as Gazetted Police Officer the detained lady failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 101 grams Said to be Brown Sugar and one android mobile phone which was kept inside in her pocket. Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses and accused lady. I also labeled and sealed all the articles under the supervision of Shri Manojit Sarkar, Inspector In-Charge of Matigara PS and witnesses and lady accused. The whole process of search & seizure has been audio & VDO graphed by videographer Sri Somnath Chatterjee. The whole process of seizure was made in between 14.45 hrs to 15.10 hrs.

Then, I arrested the above noted accused lady namely Firoja Begum-41yrs w/o Lt Md Entajul of Dry Fish Market, near Three signal, PS Matigara Dist Darjeeling after observing all formalities and informing the ground of her arrest in written and issued necessary Memo of Arrest u/s 35 (3) of BNSS. On interrogation she stated that she procured the seized Brown sugar from Chopra/Dalkhola for selling the same to her customers.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Firoja Begum-41yrs w/o Lt Md Entajul of

Dry Fish Market, near Three signal, PS Matigara Dist Darjeeling (not verified) is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the lady accused persons namely Firoja Begum-41yrs w/o Lt Md Entajul of Dry Fish Market, near Three signal, PS Matigara Dist Darjeeling (not verified) also arrange for its investigation.
