Subject: Formal complaint regarding a hit-and-run accident involving my son


Respected Sir,

I, Peter Tshering, S/o Late Philip Tshering, resident of Panchanoi Enclave, Salbari, Siliguri, wish to lodge a formal complaint regarding a road accident involving my son Ezekiel Tshering (24 years old). On the night of **30/03/2026, between 11:00 PM and 11:45 PM**, while riding his motorbike bearing registration number **WB 74 BQ 3005** on the road in front of the C.P. Office, he was hit from behind by an unidentified vehicle. The offending vehicle did not stop to provide assistance and fled the scene immediately.

Local police personnel on duty arrived at the scene, secured my son, and admitted him to Siliguri District Hospital. I was informed of the accident by the police, after which I rushed to the hospital. Due to the seriousness of his injuries, I later transferred my son from the District Hospital to Neotia Getwel Multispecialty Hospital, where he is currently undergoing treatment. I kindly request you to register an FIR under the relevant sections, identify the offending vehicle, and take strict legal action against the driver responsible for this incident.


