Sir,

In producing herewith one arrested accused person namely Babla Das (44 Yrs) S/O Lt. Suresh Das of Tumulpara opposite Sarkar Sweets, W/No. 04, SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles viz.

(1) Total 21 (Twenty One) bottles of "Himalayan Gold 60° UP country spirit" containing 600 ml. each. Total 12.6 Ltrs.

I, ASI. Binod Chhetry of Khalpara TOP under Siliguri PS, SPC, hereby lodge this written complaint against the above noted accused person to the effect that on 02.04.2026 at 20.35 hrs received credible information from a secret source that one person procured huge quantity of illicit liquor without any documents/license and selling the same to his local designated customer at Tumlpara, W/No. 04, SMC, PS-Siliguri, Dist.-Darjeeling. Accordingly informed the same to O.C, Khalpara TOP and being directed, myself along with other officers & force viz. PSI. Mrityunjoy Kundu, ASI. Mantu Barman, ASI. Majaffar Rahaman Mandal, C/390 Sujit Paul & C/1561 Sandip Modak left for Tumulpara, under Khalpara TOP to work out the veracity of the information. This refers Khalpara TOP GDE No. 45, dated 02.04.2026.

On arrival near Tumulpara More, W/No. 04, SMC, Siliguri, being pointed out by the source, found one person was selling illicit liquor to the local customers in his shop, situated at Tumulpara More, w/no. 04, SMC. Accordingly we apprehended him after maintaining all legal formalities and recovered total 21 (Twenty One) bottles of "Himalayan Gold 60° UP country spirit" containing 600 ml. each. Total 12.6 Ltrs. from his exclusive possession. At the time of conducting raid, the local customers who were taking liquors are able to flee away from the spot.

During interrogation the accused failed to produce any documents/license in support of the same and stated that he was selling the same illegally to the local public of Tumulpara area for his wrongful gain and livelihood. Accordingly, I seized total 21 (Twenty One) bottles of "Himalayan Gold 60° UP country spirit" containing 600 ml. each (total 12.6 Ltrs.) under proper seizure list in presence of witnesses and duly signed by them & the accused person. The seizure was made in between 21.00 hrs to 21.10 hrs. under videography. I, then arrested the said accused person u/s 35(1) of BNSS after explaining charges against him and communicating ground of arrest.

Hence, under the above noted circumstances, I am submitting this written complaint against the above noted accused person **Babla Das (44 Yrs) S/O Lt. Suresh Das of Tumulpara opposite Sarkar Sweets, W/No. 04, SMC, P.S- Siliguri, Dist.- Darjeeling** for starting a specific case under relevant section of Law and arrange for its investigation.
