Sir,

In producing here with the one arrested accused person namely Aman Hela @ Kalu 18 yrs S/O Kiran Hela of Lichu Bagan, ward no- 18, PS- Siliguri, Dist- Darjeeling along with the seized articles, with all connecting papers.

I ASI Debasish Das S/O- Haripada Das of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Aman Hela @ Kalu 18 yrs S/O Kiran Hela of Lichu Bagan, ward no- 18, PS- Siliguri, Dist- Darjeeling to the effect that on 03.04.2026 at about 00.15 hrs received a secret source information that one person namely Aman Hela is storing and selling huge quantity of liquor illegally, at Bagrakote, Bus stand, beside of Biswajit Pan Ghar, ward no- 18, under Siliguri PS. The fact was diarized in G.D (vide GDE no- 126 Dated- 03.04.2026), accordingly informed to IC Siliguri PS and as per his direction, myself along with ASI Subir Sen, ASI Minhaj Al Kader, Const- 160 Soumen Sarkar of Siliguri PS left for Bagrakote, bus stand, to verify the veracity of the information. At about 00.35 hrs I along with my accompanied officer and force reached at Bagrakote and kept our vehicle at considerable distance from the spot and on being shown and identify by the source. I along with my accompanied team held raid at Bagrakote bus stand against Aman Hela and managed to apprehended the said person. On searched I recovered Twelve (12) bottles of Himalayan gold 60 up Country spirit each bottle containing 600 ml, (total 7.2 litters). (Total value of RS/- 170 X 12= Rs- 2040/-). On interrogation he disclosed his identity as Aman Hela @ Kalu 18 yrs S/O Kiran Hela of Lichu Bagan, ward no- 18, PS- Siliguri, Dist- Darjeeling. On-demand he failed to produce valid license or documents in r/o said liquors. On further interrogation he admitted his guilt and stated that he sells liquor to his design customers without valid licence or documents for his wrongful gain. Accordingly as he violated the rules and norms of Bengal excise act, as such I seized the same viz Twelve (12) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (total 7.2 litters) and each bottle M.R.P Rs- 170/- (Total value of seized articles 12X170= Rs-2040/-) from the exclusive and conscious possession of Aman Hela @ Kalu 18 yrs S/O Kiran Hela of Lichu Bagan, ward no- 18, PS- Siliguri, Dist- Darjeeling (the searched, seizure and labelled was made in between 00.55 hrs to 01.15 hrs) the whole processes of search and seizure was made under video graphed in presence of available witnesses, duly sign by the accused as well as witnesses. Then I arrested him u/s 35(1) of BNSS after appraise him the ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person namely Aman Hela @ Kalu 18 yrs S/O Kiran Hela of Lichu Bagan, ward no- 18, PS- Siliguri, Dist- Darjeeling under proper section of law.
