Madam Officer,

I, Smt. Reena Agarwal aged 52 years, wife of Sri. Dalu Ram Agarwal presently residing at 33, Rev. Sati Mandir Road, Gangonagar, Ward No.- 05, Siliguri-734005 hereby being compelled to file this written complaint against my step son **SOHIT AGARWAL** S/O- Sri. Dalu Ram Agarwal & 2. **DALU RAM AGARWAL** S/O- LT. Banwari Lal Agarwal who is my present husband for continuously torturing me physically, mentally, inhumanly and immorally that is being vividly described below:

1. That I was a widow of Lt. Sunil Kumar Agarwal with whom I have two children- Ayushi Agarwal (Daughter) & Adesh Agarwal (Son).
2. That on 09/09/2016, I was legally married to Sri. Dalu Ram Agarwal S/O- LT. Banwari Lal Agarwal, a widower with one son from previous marriage Sri. Sohit Agarwal.
3. That during my marriage the express and implied dowry conditions by Sri. Dalu Ram Agarwal was fulfilled with Cash amount of Rs. 11,00,000/- (Eleven Lakhs) only, immense quantity of Gold Jewellery and Silver Jewellery.
4. That right from the beginning of our marriage I have been facing continuous physical, mental, immoral torture from both the persons subject to death threats and death like circumstances multiple times due to regular more and more dowry demands in kinds and cash which was impossible for me to provide to the both two persons.

5. That I have been forcefully conspired and compelled by both the above named persons to sell my properties, i.e. One Flat worth Rs.25,00,000/- (Twenty Five Lakhs)only, Fixed Deposit worth Rs.10,00,000/- (Ten lakhs)only of my then minor daughter Ayushi Agarwal and hand over the sale amount to the named named persons, which I had to and did to get relief from torture but inspite my handing over the entire consideration amounts realised out of the above mentioned Sale of my Flat worth Rs.25,00,000/- (Twenty Five Lakhs)only, and premature withdrawal of Fixed Deposit worth Rs. 10,00,000/- (Ten Lakhs)only in the name of my then minor daughter.
6. That even after deliberately conspiring in cold blooded criminal intent to throw me into absolute begging condition by the above named two persons, the tortures increased more and more, severe and severe for demand of more dowry.
7. That on the night of 27/03.2026 at about 9:00pm, an auspicious Ram Navami night I was subject to heinous Physical torture by **SOHIT AGARWAL** S/O- Sri. Dalu Ram Agarwal while I was performing my puja (lighting deepak) outside my residence. **SOHIT AGARWAL** was under the influence alcohol and ganja (weed). He was continuously abusing, heckling, pushing inappropriately and immorally while exhaling weed smoke on my face, holding my face by my cheek- threatening me to kill with the lighted deepak.
8. Under that circumstances I was terrified and my heart starting to beat very fast, as if I would have a stroke. I immediately called my brother Sri.Rajesh Agarwal who then took me to his residence.

That under the above undergoing heinous and spine chilling torture, I feel absolutely unsafe, traumatised, unsecured and being subject to series of catastrophic criminal acts by said **SOHIT AGARWAL**, I seek your immediate intervention to book **SOHIT AGARWAL** under stringent and appropriate sections of law for ends of Justice.
