During that time Roni Roy Devashish Roy, Ajay Mahato and some of their friends were downstairs, drinking alcohol and using abusive language. When my brother went to ABK them. Why they were abusing they severely assaulted him. They also assaulted some of the guests at my house and attached my entire family. They vandalized my vehicle and broke the glass of my house. My brother, Bishal Paulson is currently in serious condition and admitted to the civil hospital. And I am pregnant from 15 days and they also pushed me and beat me very badly. (After that we all take medical treatment from civil hospital. (So I kindly request you to take legal action against above named person.) And Doctor said me to take treatment of my pregnancy.
