Most Humbly, I Smt Mamta Singh, Wife of Sri Souvik Singh And Daughter of Sri Parma Singh, aged about 24 Yrs, Resident of Bidhan Market, Khudiram Pally, Ward Of 11 SMC, P.O & P.S-Siliguri, Dist-Darjeeling, Presently Residing At Ganga Nagar, Near Hanuman Mandir Road, Ward No-5 Of SMC, P.O & P.S-Siliguri, do here by inform you that I was married with Sri Souvik Singh Son of Late Harishankar Singh, R/o Bidhan Market, Khudiram Pally, in the year 2024 at Siliguri with concern of both family Further I inform you that I am belonging with Poor Family due to which my marriage was solemnized at Hindu Temple with Hindu Custom and rites and after y marriage I came to know that my husband is addicted of alcohol and gambling as well as he has some illegal and illicit relationship with another girl but due to my family reputation I did not say about all the incident with my family resulting in he behave gone changed with me and came to house in intoxicated situation in every night and started assaulting me physically, mentally and sexually also. When I ask all the incident to my mother-in-law, Brother-in-law and Sister-in-law but they also blamed me they pressurized me to do all work of housework like a maid and did not give me food many days, in the year 2025 I gave birth a baby child (Girl) and after her birth my Mother-in-law and sister in law started tortured me regarding my baby gender. They pressurized me to leave my daughter at my parental house and they did not take responsibility of my daughter as well as my husband say that I not accept this child because she is girl but in all condition I did not leave my matrimonial house but in this year 2026 my husband pressurized me to another time for conceive baby and started assaulting me sexually, he have physically intimate with me forcefully and demanded unnatural sexual relationship, every night he try to tort my cloth forcefully, when I said all the incident to my mother-in-law then she say me that your mother not give us any type of dowry and you should live with my son however he want. My husband force me to take money from my parents for starting new business when I refuse then he started assaulting me physically and started torturing me they stop my food lastly I decided to live my matrimonial house and came to parental house when my mother and father go to their house for solve this issue then they insulting them and say that if my mother and father wants that I live with my husband then they have to pay them as well as demand that my parents take custody of my baby child either my husband give me divorce.

Now I came before to you for informing all the incident and pray before you to kindly registered my complaint as F.I,R against my Husband Souvik Singh and his family members namely Shilpi Singh (Sister-in-law), Gulab Singh (brother-in-law), Malti Singh, (Mother-in-law) Pratik Singh (brother-in-law) as per law and take necessary strict action against all my relative for assaulting me and my baby child as well as demanding *dowry* from my parents .
