Subject: Complaint regarding illegal triple talaq, dowry harassment, domestic violence, criminal intimidation, forced eviction, and cruelty

Respected Sir/Madam,

I, Sabina Khatoon, wife of Md. Samsher Alam, residing at Ashraf Nagar Masjid Road, Haiderpara, Ward No. 40 under Siliguri Municipal Corporation, respectfully submit this complaint against my husband and his family members for severe mental and physical harassment, illegal pronouncement of triple talaq, continuous dowry demands, threats to my life and cruelty.

That I was married to Md. Samsher Alam on 23rd July 2024, as per Muslim rites and customs. After marriage, my husband and his family members started harassing me for dowry. They continuously demanded a two-wheeler motorcycle, cash from my maternal family, and also insisted that my family construct a pakka house for them. When these demands were not fulfilled, I was subjected to continuous mental and physical torture.

During the course of my marriage, I also found suspicious contacts and communications with multiple women on my husband's phone. He frequently used to go out with different women, which caused me severe mental harassment and distress.

On 28th March 2026, my husband pronounced instant triple talaq over a phone call, which is illegal and void under the Muslim Women (Protection of Rights on Marriage) Act, 2019. During the same call, he stated that he was in Delhi with another woman and that he intends to marry her and start a new life, thereby abandoning me. At present, my husband is not in the city and is deliberately avoiding his responsibilities towards me.

On the night of 29th March 2026, I was subjected to continuous harassment and threats by my in-laws. They threatened to kill me overnight, and my mother-in-law was spitting on me repeatedly, causing extreme humiliation and mental trauma. Fearing for my life, I informed my sister and mother to come and take me from my matrimonial home. At around 11:00 PM, my sister arrived, but my in-laws locked me inside the house and did not allow her to enter.

Thereafter, my sister informed Bhaktinagar Police Station, following which a police patrolling team arrived. With the assistance of the police personnel, I was safely taken out of the house and thereafter I went to my mother's rented residence at Upper Pukajote, Anchal, Champasari, Siliguri – 734003, where I am currently residing with my mother and sister.

The details of the accused persons are as follows: Husband – Md. Samsheer Alam, Father-in-law – Md. Rakib Alam, Mother-in-law – Sabina Begum. Due to continuous harassment, dowry demands, extramarital conduct, and physical and mental cruelty, I am under severe distress and fear for my safety and well-being.

Therefore, I request you to kindly:

- Register an FIR against my husband and his family members under relevant provisions of law for illegal pronouncement of triple talaq, dowry harassment, domestic violence, criminal intimidation, and cruelty.
- Take immediate and strict legal action against the accused persons.
- Provide me necessary protection and ensure my safety.
- Help me secure my legal rights, including maintenance and right to residence.

I am ready to fully cooperate with the investigation and will provide all necessary evidence, including call records, messages.

Kindly treat this matter as urgent.
