Subject: First Information Report (F.I.R.) regarding wrongful restraint and robbery/snatching of 4 (four) mobile phones and cash amounting to Rs. 1,00,000/- at Naukaghat Bridge.

Respected Sir,

I, Pintu Das, son of Sri Ram Bilash Das, business by occupation and deals in New and Second-hand mobile sales and services, resident of Shahanipara, Matigara Bazar, P.O. & P.S. Matigara, Dist: Darjeeling, Pin: 734010 would like to bring the following grave incident to your urgent attention for immediate legal action:

1. That I am a law-abiding citizen and earn my livelihood through the sale, purchase, and servicing of new and second-hand mobile phones in Siliguri.
2. That on March 27, 2026, at approximately around 9 PM, I received a call from an unknown number who wished to sell his Apple I-phone 17 Pro therefore I visited my client at Naukaghat More.
3. That as I reached the Naukaghat Bridge, a group of 6 to 7 unknown miscreants forcefully intercepted my path and wrongfully restrained me from proceeding further.
4. That the said miscreants, acting with common intention, used criminal force, intimidated me, threatened with intentions to kill me with several knives and other sharp weapons and snatched away 4 (four) mobile phones along with a sum of Rs. 1,00,000/- (Rupees One Lakh only) in cash, which I was carrying from my daily business transactions.
5. That I have also sustained internal injuries and visited Matigara Primary Hospital and got the treatment, and I have also attached the Medical Prescription.
6. That immediately after committing the offense, the miscreants fled the scene.
