Sir,

I, ASI Nilam Swarnakar of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Sudhir Kr. Singh (M/53 yrs) S/O Lt. Ram Janam Singh of Jyotiakali, near Driver Saheb Dhaba, PO- Fulbari Hat, PS-New Jalpaiguri, Dist.- Jalpaiguri A/P – Chandrawara, PS – Kartha, Dist. – Vaishali, Bihar under arrest along with following seized articles:

- 1.) Fourteen (14) Nos sealed Bottles of Himalyana Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 (one) bottle taken as sample for examination Marked as Exhibit-A.

I am submitting a written complaint against the above noted accused person to the effect that today on 02.04.2026 at 22.15 hrs. myself along with force performing PC Party mobile Van duty. I received source information that one person was selling Liquor illegally at Jyotiakali, near Driver Saheb Dhaba under New Jalpaiguri PS, Dist.- Jalpaiguri to its customers without any valid license. Accordingly myself along with CV – 306 Biswajit Roy, CV – 824 Niru Kr. Yadav and VP – 08 Laxman Roy all of NJP PS for Jyotiakali, near Driver Saheb Dhaba to verify the veracity of information. On arrival at the spot it was found that one person mentioned above was selling liquor illegally at Jyotiakali, near Driver Saheb Dhaba area under New Jalpaiguri PS to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 35 BNSS. as It's a violation under Bengal Excise Act. The seizure & arrest was made on 02.04.2026 in between 22.45 hrs. to 23.05 hrs (seizure Total approx 8.4 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Sudhir Kr. Singh (M/53 yrs) S/O Lt. Ram Janam Singh of Jyotiakali, near Driver Saheb Dhaba, PO-Fulbari Hat, PS-New Jalpaiguri, Dist.- Jalpaiguri A/P – Chandrawara, PS – Kartha, Dist. – Vaishali, Bihar and arrange for its investigation.
