In producing here with the seized articles viz:-

- 1) 02(Two) Number of Domestic "Bharat Petroleum" Gas Cylinder in which 01 (One) Number Fully Loaded and 01 (One) Number Fully Empty.
- 2) 01(One) Number of Domestic "Hindusthan Petroleum" Gas Cylinder Fully Empty.

Under proper seizure list. I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against One Arun Kumar Gupta (50 Years) S/O Lt. Tirtha Ram Gupta @ Tirath Ram Gupta of Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri who was illegally procured the domestic Gas cylinder at his hotel styled as "GUPTA HOTEL AND BOX SHOP" for commercial purpose without any valid documents or license to the effect that today i.e. 04.04.2026 at about 10.05 hrs vide Enforcement Branch SPC, GDE No 19/26 Dt. 04.04.2026 received an information from reliable source that above noted Hotel styled as "GUPTA HOTEL AND BOX SHOP" situated at Salugara Bazar, P.S- Bhaktinagar, Dist- Jalpaiguri using the domestic Gas cylinder at his hotel for preparing foods items for using commercial purpose for his wrongful gain.

Hence I diarized the matter vide EB, SPC GDE No. 20/26 Dt. 04.04.2026 and informed the matter to ACP EB, SPC and as per his instruction myself along with ASI Arghya Das, ASI Chandni Roy, L/C 1270 Deeptina Gazmer, C/1832 Nabab Sk all of EB, SPC left EB Office to proceed PC Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri to execute the information.

At about 12:15 hrs we reached at hotel styled as "GUPTA HOTEL AND BOX SHOP" located at Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri and contacted with source and being shown and identified by him, I along with officers and force conducted raid in the Hotel styled as "GUPTA HOTEL AND BOX SHOP" located at Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri. During search found worker are preparing/coking foods items for hotel by using the domestic Bharat and HP Gas cylinder without any valid documents for commercial purpose, On demand they failed to produce any valid documents in support of using the Bharat and HP domestic gas cylinders in the Hotel styled as "GUPTA HOTEL AND BOX SHOP" for commercial purpose.

It is crystal clear that the said person namely Arun Kumar Gupta (50 Years) S/O Lt. Tirtha Ram Gupta @ Tirath Ram Gupta of Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri owner of "GUPTA HOTEL AND BOX SHOP" located at Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri is storing and using the Domestic gas cylinders in his Hotel for his wrongful gain. As per local enquiry it came to light that the above noted person storing and using gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Arun Kumar Gupta does not have any valid Documents regarding above seized articles. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of witnesses namely

- 1) Sushil Paswan S/O Sukna Paswan Vill- Dim Dima Busty, PS- Bhaktinagar Dist- Jalpaiguri and
- 2) Debendranath Roy S/O Harandranath Roy of Vill-Gotmabari, PS - New Jalpaiguri, Dist- Jalpaiguri The seizure was made in between 12.35 hrs to 13.05 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Arun Kumar Gupta (50 Years) S/O Lt. Tirtha Ram Gupta @ Tirath Ram Gupta of Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri owner of "GUPTA HOTEL AND BOX SHOP" located at Salugara Bazar, P.O- Salugara, PS- Bhaktinagar, Dist- Jalpaiguri U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
